Meeting Called to Order

Minutes

During discussion of the minutes, CRD staff noted that the members-atlarge positions for Electoral Areas H and L are currently vacant. Commissioner Coakley has been unsuccessful in finding a member-atlarge and Commissioner Wagner is discussing the position with a possible candidate.

The Commission also examined the requirement to have the GPS/GNSS reviewed and redesigned every four years. The cost for the work is in the budget but another request may be made to Transport Canada to assume the responsibility.

During discussion of Sarvair's hangar licence renewal, it was noted that the aviation school on the hangar lease property is still in operation and that the aviation students are covered by the high school's general liability insurance.

Action item: CRD staff will contact Transport Canada to again request that the organization assume the review and redesign responsibility for the GPS/GNSS.

Action item: CRD staff will contact School District #27 to request a letter confirming that the aviation school students are covered by the high school's general liability insurance.
