# **Short Summary:**

Budget Amendment to use Community Works Funds for Office Roof Upgrade

# **Voting:**

Corporate Vote - Weighted

#### **Memorandum:**

The Cariboo Regional District (CRD) Five Year Financial Plan adopted at the March 23, 2018 CRD Board Meeting, included a Capital Expenditure in the amount of \$225,000 to repair/replace the roof over the CRD Office/Library complex in Williams Lake. The funds for the roof project were to be sourced from capital reserves. The successful bid for completing the work has come in under budget at \$196,788. The bid also includes pricing for an optional insulation upgrade to add an additional 1.5 inches of insulation to the roof. Adding the insulation would also require additional wood blocking and new perimeter flashing to accommodate the increased insulation thickness. The incremental cost for the upgrade is estimated to be \$57,242. The Community Works Fund (CWF) would be an appropriate source for some or all of the additional funds required, as the insulation upgrade aligns well with the CWF Allocation Policy priority of reducing greenhouse gas emissions. The budgeted transfer from capital reserves could be used to cover the costs of the original roof replacement (\$196,788) as well as a portion of the insulation upgrade costs (\$27,212). The balance of the insulation upgrade costs could be funded by CWF (\$30,030). Alternatively, the entire cost of the insulation upgrade could be covered by CWF (\$57,242) and the transfer from reserves restricted to the amount of the cost to complete the original scope of the project (\$196,788), leaving the excess budgeted funds (\$27,212) available for future Capital Expenditures.
