



## CARIBOO REGIONAL DISTRICT

### BYLAW NO. 5146

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to establish fees and charges for the South Cariboo Regional Airport.

WHEREAS, pursuant the *Local Government Act*, fees and charges, as well as policies determining their application, may be imposed by bylaw; and,

WHEREAS, the Cariboo Regional District has established, through Supplementary Letters Patent No. 56, a service which became a function of the Cariboo Regional District in 1981 to provide an airstrip in the south Cariboo community of 108 Mile Ranch; and,

WHEREAS, the Board has deemed it appropriate and in the interest of providing good government to impose fees and charges at the South Cariboo Regional Airport;

NOW THEREFORE, the Board of the Cariboo Regional District, duly assembled in open meeting, enacts as follows:

1. CITATION:

This bylaw may be cited for all purposes as “South Cariboo Regional Airport Fees and Charges Bylaw No. 5146, 2018”.

2. FEES AND CHARGES:

The Cariboo Regional District hereby establishes fees and charges for aircraft landings, aircraft and helicopter parking, vehicle parking, and hangar licence fees at the South Cariboo Regional Airport. Schedule “A”, attached to and forming part of this bylaw, establishes the landing fees, aircraft and helicopter parking fees, vehicle parking fees, and hangar licence fees to be charged.

3. REPEAL

“South Cariboo Regional Airport Fees and Charges Bylaw No. 4941, 2014” is hereby repealed.

## **SCHEDULE "A"**

### **SOUTH CARIBOO REGIONAL AIRPORT FEES AND CHARGES**

#### **Landing Fees**

These fees are established at \$25.00 per landing of turbo and twin engine operations.

#### **Aircraft and Helicopter Parking**

Daily rate: \$10.00

Monthly rate: \$55.00

Six-month rate: \$270.00

Annual rate: \$420.00

#### **Vehicle Parking**

Only vehicles related to airport use may be parked at the Airport.

Monthly rate: \$35.00

#### **Other**

The Region also has established a Private Hangar licence rate of \$3.85 per square meter of the hangar footprint.

\* Applicable taxes will be in addition to the fees charged.
