



## CARIBOO REGIONAL DISTRICT

### BYLAW NO. 5169

**A bylaw of the Cariboo Regional District, in the Province of British Columbia, to establish user fees for Cariboo Regional District water systems.**

**Whereas** pursuant to the provisions of the *Local Government Act*, a Board may establish services and user fees and rates to be charged for those services; and

**Whereas** the Cariboo Regional District has adopted Cariboo Regional District Water Services Management Bylaw No. 4935, 2014, which provides for the regulation and management of water systems within the Cariboo Regional District and for the terms and conditions upon which water services may be provided and for a tariff of charges for such services; and

**Whereas** Bylaw No. 4935 provides for the establishment of user rates as set out by separate bylaw;

**Now therefore** the Board of Directors of the Cariboo Regional District, duly assembled in open meeting, hereby enacts as follows:

1. Title

This Bylaw shall be cited for all purposes as the “Cariboo Regional District Water Rates Bylaw No. 5169, 2018”.

2. Rates

- A) There is hereby imposed and levied each year a water user rate, as set out in Schedule “A” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Alexis Creek water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.

- B) There is hereby imposed and levied each year a water user rate, as set out in Schedule “B” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Forest Grove water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.
- C) There is hereby imposed and levied each year a water user rate, as set out in Schedule “C” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Lac La Hache water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.
- D) There is hereby imposed and levied each year a water user rate, as set out in Schedule “D” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the 108 Mile water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.
- E) There is hereby imposed and levied each year a water user rate, as set out in Schedule “E” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Central Alexis Creek water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.
- F) There is hereby imposed and levied each year a water user rate, as set out in Schedule “F” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Russet Bluff water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.
- G) There is hereby imposed and levied each year a water user rate, as set out in Schedule “G” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Canim Lake water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.

- H) There is hereby imposed and levied each year a water user rate, as set out in Schedule “H” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Horse Lake water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.
- I) There is hereby imposed and levied each year a water user rate, as set out in Schedule “I” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Gateway water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.
- J) There is hereby imposed and levied each year a water user rate, as set out in Schedule “J” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the 103 Mile water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.
- K) There is hereby imposed and levied each year a water user rate, as set out in Schedule “K” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Benjamin water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.
- L) There is hereby imposed and levied each year a water user rate, as set out in Schedule “L” attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Lexington water system as per the terms and regulations set forth within “Cariboo Regional District Water Services Management Bylaw No. 4935, 2014”.

3. Repeal

“Cariboo Regional District Water Rates Bylaw No. 5094, 2017” and all amendments thereto are hereby repealed.
