



## CARIBOO REGIONAL DISTRICT

### BYLAW NO. 5165

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to authorize the preparation for and imposition of a parcel tax for the property owners in the Quesnel-Hixon Subdivision Erosion Protection Works Service Area.

**WHEREAS**, pursuant to the provisions of Section 202 of the *Community Charter*, being Chapter 26 of the Statutes of British Columbia, a Board may direct the preparation of a parcel tax roll for the purposes of imposing a parcel tax; and,

**WHEREAS**, pursuant to the provisions of Section 200 of the *Community Charter*, a Board may impose a parcel tax to provide all or part of the funding of a service; and,

**WHEREAS**, pursuant to the provisions of Section 5 of “Quesnel-Hixon Subdivision Erosion Protection Works Service Bylaw No. 4754, 2012”, the costs of the service are to be collected by way of a parcel tax;

**NOW THEREFORE**, the Board of Directors of the Cariboo Regional District, duly assembled in an open meeting, enacts as follows:

1. CITATION

This bylaw may be cited for all purposes as “Quesnel-Hixon Subdivision Erosion Protection Works Service Parcel Tax Bylaw No. 5165, 2018”.

2. PARCEL TAX ROLL

The preparation of a parcel tax roll for the purposes of imposing a parcel tax in the Quesnel-Hixon Subdivision Erosion Protection Works Service Area is hereby directed. This roll shall be known as the Quesnel-Hixon Subdivision Erosion Protection Works Service Parcel Tax Roll.

3. PARCEL TAX IMPOSITION

- (a) A parcel tax is hereby imposed to recover costs associated with the service established by “Quesnel-Hixon Subdivision Erosion Protection Works Service Bylaw No. 4754, 2012” and any amendments thereto.
- (b) A parcel tax is hereby imposed for each and every year that a contribution is made towards the costs associated with ownership and operation of the Quesnel-Hixon Subdivision Erosion Protection Works Service.
- (c) The Quesnel-Hixon Subdivision Erosion Protection Works Service Parcel Tax Roll shall be utilized to impose this parcel tax.
- (d) A parcel tax of one thousand dollars (\$1,000) per parcel is hereby imposed for 2019.
