



## CARIBOO REGIONAL DISTRICT

### BYLAW NO. 5167

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to authorize the preparation for and imposition of a parcel tax for the property owners in the Benjamin Water Service Area.

**WHEREAS**, pursuant to the provisions of the *Community Charter*, a Board may direct the preparation of a parcel tax roll for the purposes of imposing a parcel tax; and,

**WHEREAS**, pursuant to the provisions of the *Community Charter*, a Board may impose a parcel tax to provide all or part of the funding of a service; and,

**WHEREAS**, pursuant to the provisions of Section 3 of “Benjamin Water Service Establishment Bylaw No. 5127, 2018”, a portion of the costs of the service are to be collected by way of a parcel tax;

**NOW THEREFORE**, the Board of Directors of the Cariboo Regional District, duly assembled in an open meeting, enacts as follows:

1. CITATION

This bylaw may be cited for all purposes as “Benjamin Water Service Parcel Tax Bylaw No. 5167, 2018”.

2. PARCEL TAX ROLL

The preparation of a parcel tax roll for the purposes of imposing a parcel tax in the Benjamin Water Service Area is hereby directed. This roll shall be known as the Benjamin Water Service Parcel Tax Roll.

3. PARCEL TAX IMPOSITION

- (a) A parcel tax is hereby imposed to recover costs associated with the service established by “Benjamin Water Service Establishment Bylaw No. 5127, 2018” and any amendments thereto.
- (b) A parcel tax is hereby imposed commencing in 2019 and continuing for each and every year that a contribution is made towards the costs associated with ownership and operation of the Benjamin Water Service.
- (c) The Benjamin Water Service Parcel Tax Roll shall be utilized to impose this parcel tax.
- (d) The parcel tax amount for each parcel in any year will equal A/B where:  
A = the total annual parcel tax requisition for the service area indicated in the current year's financial plan; and, B = the number of current parcels in the Benjamin Water Service Parcel Tax Roll.
