# **Short Summary:**

Northern Health Request for Building Integrity Funding Bylaw

#### **Memorandum:**

A request from the Northern Health Authority, for Building Integrity Funding from the Cariboo Chilcotin Regional Hospital District was brought to the February 15, 2018 Committee of the Whole meeting, where it was recommended:

That the request from Northern Health for funding Building Integrity projects be denied, but the CCRHD Board would invite a long-term Building Integrity capital plan request for the standard 40% funding.

The recommendation was endorsed at the March 2, 2018 CCRHD Board meeting:

That the following recommendation from the Special Meeting of the Committee of the Whole, held February 15, 2018, be endorsed:

That the request from Northern Health for funding Building Integrity projects be denied, but the CCRHD Board would invite a long-term Building Integrity capital plan request for the standard 40% funding.

#### **Recommendation:**

That the agenda item summary from Scott Reid, Chief Financial Officer, dated September 11, 2018, regarding a building integrity funding request from Northern Health, be received.
