**Short Summary:** 2018 CRD Wildfire Report

# Memorandum:

As part of the closure of the Emergency Operations Centre at the end of the 2018 wildfire season, the CRD's EOC had Tim Conrad from Butterfly Effect Communications conduct a public survey and produce a follow up report. The survey gathered feedback on the overall response efforts and the impacts on mental health, agriculture and businesses.

The survey was available online from Sept. 20 to Oct. 1. The same questions and format from the 2017 post-wildfire survey were used to provide a comparison between the two wildfire seasons. The results are outlined in the attached report; the detailed responses from the survey are attached as well.

It is important to note that 43 people who took the survey were evacuated during the 2018 wildfires, out of the 253 respondents. 37% of people who took the survey said they spent time on evacuation alert. This makes sense since most of the evacuation orders were in rural and remote areas – places without internet access – and the survey was only available online (for consistency with the 2017 survey). The survey is still informative and useful for measuring the CRD's response, but it should be noted that the opinions of those most directly affected by the 2018 wildfires, in terms of evacuation orders, are not reflected in these results.
