- PRESIDENT'S WELCOME Lori welcomed all attendees to the AGM and bonspiel with emphasis on thanks to the host club Vancouver.
- MINUTE OF SILENCE For passed colleagues during 2017

#### 2. ADOPTION OF AGENDA

Moved by Terry Pipkey; 2<sup>nd</sup> BY Eric Rosen; Carried.

3. ADOPTION OF 2017 ANNUAL GENERAL MEETING MINUTES - as circulated Moved by Henry Vis; 2<sup>nd BY Robin Crocker;</sup> carried.

#### 4. BUSINESS ARISING FROM MINUTES

- 2018 WCBCA Provincial Play downs- the event ran smoothly and all had a good time.
- 2018 Canadian Visually Impaired Curling Championships (CVICC) - Although Kelowna earned the privilege to attend as Team Canada as well as to send a second team to represent BC,, they had to pass the second opportunity onto Prince George Who have accepted and will attend next month in Ottawa.
- 5. PRESIDENT'S REPORT Written report read by Carol Kent; copy attached

The main focus for the past year was the task of updating the association bylaws in accordance with Schedule B of the BC Society Act and completing the transition process. This has been done and will be discussed in more detail later on the agenda.

The president outlined observations and suggestions regarding the future growth of the WCBCA including consideration to other sources of funding that don't restrict future development as which appears to be the case with changes to the Gaming policies.

Eric Rosen questioned why we were not receiving more funding from Gaming and that rather than sit back and accept this, should we not be contacting local MLA's. Marilyn Vinson suggested someone take this on if there is a need while Jim Hall reminded members that this was discussed in the past; some clubs did so and some did not. Marilyn further suggested that a committee be established to focus on further discussions regarding the approach to the Gaming Branch; perhaps this is an executive committee matter. Further explanation re gaming to be included in the Treasurer Report. Robin Crocker queried how is the gaming involved and Lori explained that through the grant application process the Gaming Branch are the ones that provide the funding for the WCBCA and even though there are many guidelines and restrictions, members should be thankful for the amount we do receive. Consideration to alternative fundraising methods are recommended for the future; should the WCBCA look at the association as a whole pursuing alternative funding or should the additional

fundraising be the responsibility of each club; perhaps increase the club assessment fees which would put more dollars in the association coiffures. Although no detailed discussions took place or decisions were made, Wendel Schwab agreed with the suggestion that clubs raise the assessment fees. It was noted that if we show gaming we are raising additional funds, it may assist Gaming to approve additional funding.

In closing, the president reminded members of the busy year ahead of us with the 2019 western championships being hosted by British Columbia.

Lori moved to have her report accepted as presented; 2<sup>nd</sup> by Wendel Schwab; Carried.

#### 6. TREASURER'S REPORT

Jim Vinson referenced the 2016-17 audited Financial Statement circulated to members on December 2, 2017; No questions.; copy attached.

The 2017 Gaming grant was approved in the amount of \$9,000 which is \$1000 more than last year.

New guidelines eliminate the former travel day perdiums, however, eligible travel day expenses can be submitted with receipts. Jim established a new Travel Day Expense Form to be completed by Clubs and sent via email to the Treasurer along with receipts via regular mail.

It is vital that clubs keep track and submit volunteer hours to the Treasurer no matter how minimal the time; up to 12 hours a day while at bonspiels even Ottawa.

Jim reviewed the established procedure for teams to submit their CVICC entry fees through the WCBCA; The club going to Ottawa will submit cheque to treasurer and treasurer will submit payment to CCB national and with the team rosters for Ottawa he is able to submit an additional out-of-province application to Gaming requesting permission to use a portion of the unused transportation amounts in the corresponding year budget.

A WCBCA-Financial policy manual-statement guidelines has been created to replace Bylaw 63.15 to be discussed further on the agenda.

Reminder that the host club must submit the following year playdowns budget to treasurer by mid-March of the current calendar year.

The Treasurer position plays a vital role in the association and is governed by rigid Gaming guidelines. Jim expressed his intent to resign from this position in 2019 and encouraged future consideration by someone for this position; he is willing to train in advance and assist with the Gaming grant application during the transition to a new treasurer.

In regards to accommodations for the host club, it is recommended that a definitive policy be established in this regard; i.e. should host club members stay at the

hotel or not? There could be rationale Ifor and against this depending on how far members must travel to and from the event location.

Further discussion ensued regarding broom bag costs which are currently \$25 if travelling by airlines. Jim advised that this expense can be claimed as part of the travel day expenses, but all costs exceeding the \$25 per member per travel day will not be covered. It may be a sign of the times that alternative arrangements for funding must be made and should be further discussed amongst the WCBCA executive.

Frank Costello mentioned that the Kelowna club provides individual perdiums to team members leaving the cost to transport the broom bag for submission to WCBCA for travel day expense reimbursement. Lori added that 100 Mile House does the same.

Jim moved to have his report acceptaed as presented;2<sup>nd</sup> Eric Rosen; Carried.

Before moving on, Lori apologized for not bringing up this next point at the beginning of the meeting, but as a result of the bylaws review it was discovered that the eligible voting clause has not been followed properly for the past few years. The current bylaws reflect that full clubs are entitled to two voting members and associate clubs entitled to only one vote. Over the past few years, all members in attendance at the AGM have been voting and the current proposed bylaw change indicates that the eligible voters will be the five members on each competing team at the Provincial Playdowns. Although

there has been no opposition on the way it has been done to date, Lori confirmed what was the will of the members for today's meeting; the current or proposed bylaw and it was decided to proceedd with the full five members from each competing team would be eligible to vote.

#### 7. STATUS OF SOCIETY REPORT

It was noted that it is a requirement of the WCBCA to report on the status of the society each year. The report must be filed once a year with a FILING fee to the BC Registrar, and currently, the association is up-to-date and in good standing.

#### 9. NEW BUSINESS

- Resolutions none were received by clubs
- BC Society Act Transition as approved at last year's AGM, the \$40 was submitted to purchase the BC Society Transition package from which the association bylaws were updated in accordance with Schedule B of the BC Society Act and circulated to clubs on December 2, 2017. All BC Societies were given a 3 year window to complete this process and it is by law that compliance is necessary in order to remain in good standing.
- Approval of Revised Bylaws Highlighted changes include the following:

CONSTITUTION

numbers 3 to 5 points in the prior WCBCA Constitution had to be incorporated into the Bylaws so these points from the Constitution are now clauses 47 1 to 3 and remain unalterable as per the Society Act regulation

- 47 (1 In the event of the discolution of the Association, funds and assets of the Association, after the satisfaction of its debts and liabilities, shall be given or transferred to such organizations with similar purposes in British Columbia as may be determined by the members of the Association at the time of the dissolution.
- (2) No director or officer shall be remunerated for being or acting as a director or officer, but after a majority approval of the directors, a director or officer will be reimbursed for all expenses incurred on the approved item.
- (3) Articles 47(1), (2) and (3) of these bylaws are unalterable in accordance with the Society Act

#### **NEW CLAUSE**

63.4a NEW CLAUSE HAS BEEN ADDED PERTAINING TO PAYMENT OF THE CVICC

63.4a The entry fee for the Canadian Council of the Blind (CCB) National Canadian Visually Impaired curling championships (CVICC) will be sent to the Treasurer of the WCBCA within sufficient time for the Treasurer to then forward the payment on to CCB National.

As a result of feedback from the Vancouver club, the following changes have been made to the most recent draft bylaws and the copy attached to these minutes include these changes.

#### ADDITION TO CLAUSE

- 63.14 The BC Playdowns will consist of a round robin of one (1) team only from each club or associate club. If there is an uneven number of competing teams the host club may enter an additional team to make a full draw with no byes subject to available funding.
- 63.15(B) TO BE DELETED FROM BYLAWS AND INCORPORATED INTO A FINANCIAL POLICY copy attached.
- 63.15 (b) The WCBCA will pay the transportation for up to a five member team as defined in 15(a-d) to participate in the BC Playdowns. The cost of the most economical route of transportation will be reimbursed.
- 63.15 c BECOMES THE NEW 63.15 b WITH AN ADDITION RE VOTING
- 63.15 (b) The Association will be responsible for the costs of the President and Treasurer to attend the AGM and Provincial Playdowns when they are not part of a participating team, but will not have a vote except for the president in the case of a tie.

Motion to accept the WCBCA Bylaws as amended; Moved by Dan Martell; 2<sup>nd</sup> byDonna Lowen; Carried. with comment from Terry Pipkey about accepting the bylaws in order to file before the deadline, but recommends a future review and changes as needed.

- 2019 WCBCA Provincial Play downs to be held in 100 Mile house. Lori asked if there was a preference to week days versus weekends and DonnaLowen stated whatever works best for the host club. Tenative dates January 10<sup>th</sup> to 13<sup>th; all in agreement</sup>.
- 2019 WBCA Championships Lori advised that Corry Stuive assisted in researching the possibility of hosting in Victoria versus Kamloops and it was decided that Kamloops was the better choice if all agreed; all in agreement.
- The Thompson Hotel is not available but a sister hotel. Within the same block is being considered. Hosting is subject to funding, Terry suggests contact be made with the Lions Clubs in Kamloops. Lori is willing to led, but would like assistance with the planning and would appreciate discussions take place before anyone approaches potential funders. Wendel Schwab suggested contacting other organizations for assistance.

#### 10. ELECTIONS

- President Lori said she is not seeking re-elections and with the approval of members present Lori is running the elections; declared all positions vacant.
- PRESIDENT: Robin Crocker nominated Fraser Hiltz and after the 3<sup>rd</sup> call for nominations, hearing none Fraser Hiltz is President by acclamation.
- 1st VICE-PRESIDENT: Although not in attendance, Bill Mah has said he will let his name stand for this position.

- and after the 3<sup>rd</sup> call for nominations, hearing none, Bill Mah is 1<sup>st</sup> VP by acclamation.
- 2nd VICE-PRESIDENT: RobinCrocker nominated Jim Hall (declined) Terry Pipkey nominated Wendel Schwab and after the 3<sup>rd</sup> call for nominations, hearing none, Wende Schwab is 2<sup>nd</sup> VP by acclamation.
- 3<sup>rd</sup> VICE-PRESIDENT: (optional) EricRosen nominated Jim Hall (declined). Eric Rosen nominated Rob Camozzi, and after the 3<sup>rd</sup> call for nominations, hearing none, Rob Camozzi is 3<sup>rd</sup> VP by acclamation.
- TREASURER: Jim Vinson will let his name standard after the 3<sup>rd</sup> call for nominations, hearing none, Jim Vinson is Treasurer. Jim insists this is his last year in this position.
- SECRETARY: Robin Crocker nominated Carol Kent (declined). Marilyn Vinson nominated DonnaLowen (declined). Eric nominated Caroline Markel (declined). Wendel Schwab nominated Terry Pipkey and after the 3<sup>rd</sup> call for nominations, hearing none, Terry Pipkey is secretary by acclamation.

### SIGNING AUTHORITY

- It was decided to leave the current 3 signing officers, Jim Vinson, Lori Fry and Terry Pipkey on file and add Fraser Hiltz.
- 11. Adjournment Eric Rosen moved to adjourn Carried.
