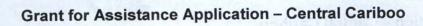

Project Overview

The Gavin Lake Forest Education Society has been providing free outdoor education to school children in the Cariboo for the last 23 years. Our aim is to bring as many grade 6 students through our program as possible annually.

For years we have been letting the forest creep in around the camp to increase educational opportunities but mostly just for aesthetic reasons. However the 2017 Wildfire season brought home the fact that we need to manage our interface risk a little more aggressively. We would like to begin a long term and ongoing process of making the camp "Firesmart" by following current pruning and thinning guidelines set out by the province of BC.

We are expecting to bring on another staff member in the near future and we certainly have no shortage of volunteers who will help us carry out this work. Our issue is removing the waste wood afterwards. Removing the branches and smaller stems to the local dump is almost an hours round trip with not much material being taken each time.

On the other hand, we are regularly receiving donations of wood chips for our trails, our obstacle course and our archery range. These usually have to be brought from Williams Lake, a 2 hr round trip.

All of this takes time, something the staff at camp never has enough of.

It only makes sense to chip our own waste from our thinning/pruning activities, eliminating hours of travel, fuel costs, as well as removing potentially dangerous wood waste piles around camp. The product of our chipping can go directly onto our trails, saving even more travel time.

We would be grateful if we could be considered for a "Grant for Assistance" this year so we could purchase a chipper and get the program in motion as soon as possible.

2017 Treasurer's Report

The figures presented in this report are derived from the Treasurer's records & from the Year-End accounting for 2017 that was prepared by Cameron & Co., which was provided at a reduced cost to us this year. Year-end reporting for 2017 has been submitted to the CRA.

Our Investment Savings were untouched in 2017. There were no withdrawals and no deposits and at the end of 2017, the balance was \$98,348.00 (Market Value, \$100,796.00).

Once again we received the Summer Student grant from the Federal Government for \$4,357.00. The total employment cost to the GLFES for the Summer Student for 2017 was \$6,823.35 for Rhianne Ferdinandi. Cameron & Co. Accounting in Williams Lake administered the payroll once again at no charge. They included the provision of the employee record of employment and T4 slip.

Donations for 2017 were \$91,989. Donations were received from Tolko, West Fraser & Norbord, totaling \$11,500. The Cariboo Woodlot Education Society once again contributed \$20,000 and Moss Rock Park donated \$10,000. A list of all other donors over \$500 is included on Page 2.

Due to the unprecedented wildfire season, both Camp Rentals and Viksten House Rentals were lower than forecasted. The total rental income for UBC Office, Camp Rental & Viksten House was \$70,469.00.

Our new water system and well cost approximately \$33,000 in 2017 and will cost a further \$10,000 in 2018 to complete the final UV phase of the system.

Looking forward to the remainder of 2018, the largest financial commitment is our new First Aid Cabin. The Moss Rock Park Foundation and the Cariboo Woodlot Education Society are donating \$130,000 for this purpose.

This was a completely crazy year for our school program but we are proud to say we carried on and made it happen despite the after effects of the wildfire season as it played out in our backyard (in fact on both sides of Gavin Lake).

We weren't sure we would begin on schedule as the camp was still under an "evacuation alert" and we were also within 2km of an active fire. Fortunately that fire was completely contained and we managed to get the alert lifted and permission to proceed just 3 days before the program was meant to begin. Much credit has to go to the participating class teachers in that first week who managed to get their classes organized on very short notice. Then we had to round up a few of our instructors who were busy fighting fires elsewhere.

Everything looked good until the 3rd week of the program when our well ran dry. Initially we thought this was owing to the 6 million estimated gallons of water pulled out of the lake by water trucks this summer, but once we examined the well we realized it was on its last legs. Incredibly, it only took a day to install a new well as all the contractors involved were extremely accommodating. It did mean we had to cancel one session (two classes). These two classes will come out to camp during our 2018 winter school program so won't miss out on the opportunity.

School District #74 had to cancel completely this year as most of those kids/families/teachers had been through a pretty bad fire and nobody really wanted to leave home. We filled their slot with others on our standby list.

As usual our staff were the superstars that keep the program ticking over like a well-oiled machine.

We had 20 teachers and 36 parent chaperones fill in our questionnaire. Highlights:

- -90% of the teachers said facilities and food were "excellent"
- -100% of the teachers would like to come again and would recommend the program
- 100% of the teachers rated the organization and modules as "excellent"

- 95% of teachers rated staff as "excellent"
- 86% of the parent chaperones rated the overall experience as "fantastic"
- -83% of parents rated the kids overall experience as "fantastic"
- -94% of the parents said they were well prepared in advance by their childs teacher.

With 624 free of charge school participants at camp this year it means our cost/person comes in at \$57/person for a 3 day trip with all meals, cooking, accommodation and instruction and bussing.

-note.... this does not include regular costs of running a camp during the school program like propane, hydro, maintenance and admin staff, insurance and supplies.

-attached is a list of donors that specifically funded the school program, but I have also included other sponsors who helped fund infrastructure projects as well as general operations and maintenance. We really couldn't run the school program without the infrastructure in place and well maintained.

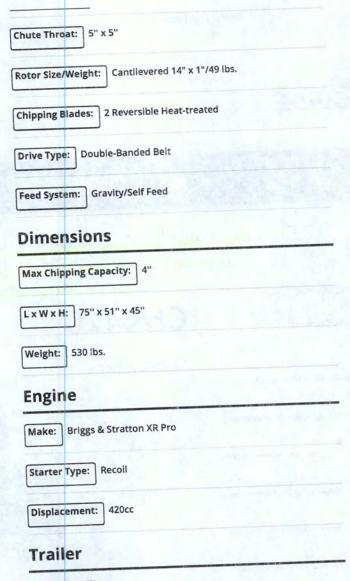
