- Income statement from last year we made quite a bit more than last year.
 \$61,000.00 of that was from the rental of our building last summer during the wildfires last summer. However, with receiving that large rental we are still down
 \$11,000.00 as compared to the previous year, due to lack of other rentals of our building throughout the rest of the year.
- Current balance: \$105,000.00.
- With this large balance in our account, it may affect our gaming grant that we
 normally receive (approx. \$23,000.00). We will need approx. \$15,000.00 for
 expenditures from April 1st to Sept. 1st, and an additional \$10,000.00 for associated
 start-up costs.

- Discussion occurred about the possibility of weekend practice time.
- Rick Miller suggested a drop-in family practice on Sunday afternoons throughout the season. There could be soup/sandwiches, and drinks sold as well.
- Discussion occurred about advertising the Sunday drop-in sessions in school newsletters. Lynda Terry volunteered to put posters up around town in the Fall to advertise Curling events for the upcoming season.
- o Oct. 15th Leagues start.
- Winter Break Dec. 24th Jan. 6th
- o Curling will resume on Jan. 7th

• Set dates for Bonspiels

- Laura Ball was in Quesnel last weekend. Discussion about changes to Bonspiel dates occurred.
- o Combined Men's/Ladies Bonspiel: Feb. 22nd 24th, 2019
- o Open Bonspiel: Jan. 25th 27th, 2019

Robert Gudbranson made the following motion: "to accept the last three new business items". Seconded by Ryan Bailey. All were in favour. Motion carried.

Dues for 2018-2019 Curling Season

- Ryan Folz made the following motion: "to have a 5% membership fee increase in all leagues except for the Junior League".
 - Seconded by Bruce Geier. All were in favour, except two members. Motion carried.
- The following discussion occurred:
 - Curling clubs with 6 rinks are expensive to maintain.
 - A suggestion was made that the 2nd league be increased to a 25% discount.
 - Another suggestion was made to have someone come in and see if our rink can be transformed into a 4 sheet rink instead of 6 rinks. However, after discussion occurred, it was decided that this would probably not be possible.
 - John Dryden said that he'd rather see an increase in 5% of membership rather than 5% increase in membership dues.
 - There was concern raised in regards to gaining new members with increased dues.

- Robert Gudbranson introduced the idea of a free open/mixed doubles league from October – December. Then in January it would become a formal league with a small fee.
- Is there a possibility of having a half year membership?

• Ways to increase membership:

- Rick Miller suggested that we brainstorm ideas to help improve our membership numbers. It is also very difficult for new curlers to curl against teams who are more experienced. It would be great to have some coaching to better learn the sport. Rick Miller suggested that Friday night could be a fun league, where if it started at 6:30pm and the first half hour could be a practice.
- It was also discussed that we need members to volunteer their time to help coach. A suggestion was made that a schedule could be set up, so that each team would be responsible for helping coach on certain nights.
- Another idea put forward was to encourage members to be willing to split up their experienced teams to invite newer curlers on their team.
- Jessie Folz mentioned that on Friday nights, they experimented with a few ways of mixing up the teams to make it more fun and to help the newer curlers.

Open/Mixed Doubles League

- The first half of the season would be an Open Doubles League that would be free for members. Play would occur on the free sheets available, probably on Tuesday or Wednesday nights. Non-members could pay a \$5.00. From January to March, it would become a formal league with a small fee.
- Laura Ball made the following motion:
 - "That we start an open doubles league for the first half of the season.
 Further details to be announced by executives and will be revisited at the end of December".
 - Seconded by Shane Doddridge. All were in favour. Motion carried.

• Review 5 Year Capital Plan (see attached)

Members reviewed the 5-year capital plan that was handed out.

Relocate funds for Capital Projects

- Ryan Bailey made the following motion:
 - "that we move \$50,000.00 of our bank account balance to a restricted capital improvement fund".
 - Seconded by Lynn Geier. All were in favour. Motion carried.

• Gaming Grant

- Ryan Bailey is going to work on submitting the Gaming Grant by May 25, 2018.
- Discussion occurred that it is possible that we may not receive the gaming grant due to our larger current bank account balance.
- Rick Miller brought up the idea that we put forward more money into the Capital Improvement Fund and if we need more funds, we could transfer it back after approval by the executive committee.
- John Dryden suggested that we move the amount that we received from the rental during the fire situation last summer (\$61,000.00), plus the amount that we've saved from the capital improvement fee.
- Rick Miller made the following motion:
 - "That we amend the previous motion of moving \$50,000.00 into our Restricted Capital Improvement Fund to moving \$75,000.00 into our Restricted Capital Improvement Fund".
 - Seconded by Ryan Bailey. All were in favour. Motion carried.

• Election of Officers:

- President: Robert Gudbranson is stepping down from President.
 - Ryan Folz nominated Shane Doddridge as President. He will let his name stand at President.
 - Ryan Bailey nomintated Simone Groundwater as President. She declined.
 - Shane Doddridge nominated John Dryden at President. He declined.
 - Shane Doddridge accepted the position as President.
- o Vice President: Ken Hall will stay on as Vice President.
- Treasurer: Ryan Bailey will let his name stand as Treasurer. No other nominations. Ryan accepted the position as Treasurer.
