- Demonstrate financial need; and
- Provide a service, project or event that supports the priorities and goals of the CRD.

Services, projects or events proposed by the applicant must not:

- Offer direct financial assistance to individuals or families;
- Duplicate or replace services that fall within the mandate of senior levels of government or local service agency; or
- Support a Provincial or National fundraising campaign; AND
- Be of a commercial nature

Grants for Assistance will be provided under the following categories:

1. **Capital Expenditure** – equipment purchase, construction, repair or upgrade of facilities
2. **Event** – seed funding for new, ongoing events with diminishing support over three years
3. **Special Project** – one-time special event, program or activity

The Potato House has been operating for the last 9 years on a budget entirely derived from Government Grants. In the last three years, no grants for staffing have been successful, but we are now applying to gaming with assistance of BCAG to ensure our success. Based upon our previous successful ventures we are able to leverage current funding to receive following funding. We are also implementing funding initiative such as providing our finished compost to the community by donation, musical community events with beverage sales including our homemade sugar free rhubarb juice, honey from our on site demonstration bee hive, providing compost of paper plates and all food waste with EGOR 125 traveling composting machine at community events, gatherings and other opportunities.

The Strategi Plan for the Potato House for 2018 is to move forward with modern technological advancements to continue to provide sustainable solutions for demonstrating smaller ecological footprint to our community while providing events that attract people to our site and attract our people to other events. The Composting Machine and 2 Stage Electric Car Charging Station as well as the pursuit of new projects funded by Red Cross Community Fund are pending. Previous Years have focused on curb appeal, house renovations, community composting, community gardens. Our success is now reaching infrastructure capacity and we are looking to new ventures to continue to provide our community services.

1. Brief Description of Proposed Use of Grant Being Applied For:

We have aquired an Eco-Growth EGOR 125 composting bio-reactor that takes all organic waste including paper plates, meat and bones and produces a bio-mass that can be used in a conventional pellet stove. ~~The finished product with heat the Potato House in the colder months, surplus would be made available for sale~~ We are applying for the funding to bring our Bio-Reactor on the road to fesivals and community events via traile within the CRD region with the purchase of a Honda EB4000XCGenerator for remote operation.

2. How do you know there is a need for this service/project in our community?

Potato House has been accepting compost from all communy events from Elder's Gathing to Arts Wells to Arts on the to the recent Wildfire Info Expo for the last 5 years. We manually rip up used paper plates to allow our manual composti system to process them. We are requested to attend more events than we have staff capacity for to attend, let alone invest the time manually turning the wet heavy compost. ~~Both the volunteer operations staff have injured their backs in this process and a solution needs to be found to continue to offer this service without the heavy manual labour and hauling costs of wet raw product to our site in WL. EGOR 125 can process 125 L of waste a day and produces a light weigh, dry bio mass product that is easily stored, processed and transported.~~

Yes, all recieved and implemented, the last step is the generator to run the composting machine at events

5. Would you still be able to complete the project if you do not receive the other funds applied for?

Yes, but by transporting the compost back to the composting machine, adding time to processing and hauling costs by volunteers that are already stretched and stressed beyond capsity.

6. Please describe the impact of this application being denied or approval of an amount less than requested.

Should funds not be made available for this project to purchase this generator that is the modern, voltage regulated with EFI and NEMA receptacles needed to operate EGOR 125 remotely and oppourtiniy to promote the already very sucessful waste reduction strategies of the CRD with be lost. Already the CRD Waste Wise Program is heardied a a provincial leader and replicated in other districts, this high profile unique canadian solution to green waste at community gatherings is a media hot topic that will further build on our sucesses. Stampede Weekend and Canada day Festivites are only weeks away and Fesitval Season is around the corner with Arts on the Fly, Arts Wells, The Garlic Festival all of which produce prohibitive amounts of green waste for a manual system to accept, but is a promotion gold mine when completed easily with a modern canadian system that is not currently in use anywhere else in the world.

Every pound will be translated into methane prevention and green house gas prevention, targets than can be used by CRD for municipal and provincial reporting as well as saved hauling costs at \$100/tonne and volume of saved landfill space.
If we collect all compost at an event and more destinations request our services we are sucessful.
