

This season, we have three students & we expect more to join. Students do not pay dues.

The Christ the King Lutheran Church has for many years generously allowed the band, without charge, to rehearse on their premises every Tuesday night. As a token of appreciation, tonight we are performing at the United Church. Admission is by donation & all proceeds will be donated to the two churches. We also will be playing tomorrow at the 100 Mile Community Hall for the Christmas crafts show. As well, we are polishing up our Christmas pieces for our annual concerts at Fischer Place & Carefree Manor next month. Last month, the band participated in a benefit concert at the Hillside Community Church for the Food Bank.

We would like to raise enough money to cover the rental fee of \$425 for the Exeter Hall so we can present a concert in the new year. In the past, when we have been able to afford the hall, we have performed at the hall with admission by donation & the proceeds were donated to charitable organizations such as the South Cariboo Health Foundation & Food Bank.

We would appreciate either that the District waive the hall rental fee of 425 &/or make a grant donation to our band. Thank you for giving our request your consideration.
