## CARIBOO REGIONAL DISTRICT

## BYLAW NO. 2854

A bylaw to convert a streetlighting specified area to a local service and to provide for an extension of the existing boundaries.

WHEREAS under Section 767(4) of the Municipal Act, a regional district exercising a power to provide a service other than a general service, may adopt a bylaw respecting that service which converts the service to one exercised under the authority of a bylaw establishing the service, and which:

- (a) meets the requirements of Section 794 for an establishing bylaw, and
- (b) is adopted in accordance with the requirements of Section 802 as if it were a bylaw amending an establishing bylaw.

AND WHEREAS the Regional Board of the Cariboo Regional District established by Bylaw No. 436, cited as "Holly and Juniper Specified Area Establishment Bylaw No. 436, 1976", a specified area for the purpose of providing streetlighting within a portion of Electoral Area "E";

AND WHEREAS the Regional Board has received a sufficient petition pursuant to Section 801 of the Municipal Act, requesting an extension of the boundaries of the area serviced by streetlighting;

AND WHEREAS the Regional Board waives the assent requirements of section 795(2)(a)(i) pursuant to section 800(1)(a) of the Municipal Act and the electoral area director has consented in writing to the adoption of the bylaw;

AND WHEREAS the Regional Board of the Cariboo Regional District wishes to convert the aforesaid specified area to a local service;

AND WHEREAS it is deemed desirable to include within the aforesaid local service area those parcels of land as shown outlined on Schedule "A" attached;

NOW THEREFORE the Regional Board of the Cariboo Regional District, in open meeting assembled, enacts as follows:

1. The streetlighting service provided within the specified area created under Bylaw No. 436, cited as "Holly and Juniper Specified Area Establishment Bylaw No. 436, 1976", is hereby established as a local service for that portion of Electoral Area "E" shown outlined on the plan attached, as Schedule 'A', to this bylaw and is now known as the "South Lakeside Streetlighting Local Service Area".

- 2. The annual cost of providing this service shall be recovered by the requisition of money under Section 809.1 of the Municipal Act, to be collected by a parcel tax to be imposed in the manner provided by Section 810.1(2) and the imposition of fees and other charges fixed by separate bylaw for the purpose of recovering these costs.
- 3. The maximum amount of money that may be requisitioned annually for the service provided under Section "1" shall not exceed the greater of \$16,160 or \$1.06 per \$1,000 of assessment.
- 4. This bylaw may be cited as the "South Lakeside Streetlighting Local Service Establishment Bylaw No. 2854, 1993".
