



## CARIBOO REGIONAL DISTRICT

### BYLAW NO. 5194

A bylaw to create a new service by merging Bylaw No. 2431, 1991, cited as “Cariboo Regional District Refuse Disposal Local Service Establishment Bylaw No. 2431, 1991” with Bylaw No. 3561, 1999, cited as “South Cariboo Solid Waste Management Local Service Establishment Bylaw No. 3561, 1999”.

WHEREAS a service has been established by the Cariboo Regional District by Bylaw No. 2431, cited as “Cariboo Regional District Refuse Disposal Local Service Establishment Bylaw No. 2431, 1991” as amended;

AND WHEREAS a service has been established by the Cariboo Regional District by Bylaw No. 3561, cited as “South Cariboo Solid Waste Management Local Service Establishment Bylaw No. 3561, 1999” as amended;

AND WHEREAS the Cariboo Regional District Board deems it beneficial to merge the two solid waste management services established in the above-mentioned bylaws to provide for one solid waste management service;

AND WHEREAS consent has been received from at least two-thirds of the participants to merge the two services accordingly;

NOW THEREFORE the Cariboo Regional District in open meeting assembled, enacts as follows:

#### 1. CITATION

This bylaw may be cited for all purposes as the “Cariboo Regional District Solid Waste Management Services Merge Bylaw No. 5194, 2019”.

#### 2. SERVICE AMENDMENT

The refuse disposal service established by Bylaw No. 2431, cited as “Cariboo Regional District Refuse Disposal Local Service Establishment Bylaw No. 2431, 1991”, and all amendments thereto, and the South Cariboo Solid Waste Management Local Service established by Bylaw No. 3561, cited as “South Cariboo Solid Waste Management Local Service Establishment Bylaw No. 3561, 1999,” and all amendments thereto, are hereby merged into one service for the purpose of providing collection, removal, and disposal of waste and noxious, offensive or unwholesome substances, and the regulation, storage, and management of solid waste and recyclable material, including the regulation of facilities and commercial vehicles used in relation to these matters, within the boundaries of the merged service area to be known as the Solid Waste Management Service Area.

3. SERVICE AREA AND PARTICIPANTS

- a) The merged Service Area is all of the District of Wells, the District of One Hundred Mile House, and Electoral Areas A, B, C, D, E, F, G, H, I, J, K and L, and shall be known as the Cariboo Regional District Solid Waste Management Service Area.
- b) The participants in the Cariboo Regional District Solid Waste Management Service are the District of Wells, the District of One Hundred Mile House, and Electoral Areas A, B, C, D, E, F, G, H, I, J, K and L.

4. COST RECOVERY

- a) The annual costs for the service shall be recovered by one or more of the following:
  - 1. fees and charges imposed under section 397 of the Local Government Act (Imposition of fees and charges);
  - 2. revenues raised by other means authorized by the Local Government Act or another act; and/or
  - 3. revenues raised by way of agreement, enterprise, gift, grant or otherwise.
- b) The maximum amount of money that may be requisitioned in any one year for the service provided for under Section 2 of this bylaw shall not exceed the greater of \$6,215,839 or an amount raised by applying a tax rate of \$1.0968/\$1,000 of assessment to the net taxable value of land and improvements in the service area.
