point of first contact with Alexander Mackenzie and Simon Fraser

THEREFORE, BE IT RESOLVED that the Cariboo Regional District
Board supports Lhtako Dene Nation's application to the Investing in
Canada grant, Rural and Northern Communities stream for the Lhtako
Dene Indigenous Cultural Centre project"
