



### Q2 How well do you understand the link between your BC Assessment property valuation assessment and the calculation of CRD property taxes to provide services?





# Q3 How well do you understand that each CRD service works independently, meaning taxes collected for that service can only be spent on that service?





# Q5 Overall, how well do you understand how CRD budgets are prepared and applied?





