Re: Dog Creek Road

Dear John,

Thank you for your letter of March 13, 2019 requesting, on behalf of the Cariboo Regional District, that the Ministry of Transportation and Infrastructure assume administration and control of the Municipal portion of Dog Creek Road within the City of Williams Lake.

Although I echo your concern with regards to the condition of this particular segment of Dog Creek Road, under the Municipal Charter, all roads not designated as Arterial, by default, fall to the Municipality to own and maintain. This segment of Dog Creek Road is not a designated Arterial. Furthermore, the Municipality assumed this segment of Dog Creek Road many years ago through a self-imposed boundary expansion.

Although the road in question is in need of some potentially significant rehabilitation, it's important to note that the Ministry is not in the business of reassuming failing infrastructure from Municipalities on the basis that it is too costly to repair. Instead what we encourage local governments to do is to make application for provincial grant opportunities that are in place to support local proposed infrastructure improvements. It is my understanding that there are various grant opportunities currently available to the City, through both the Ministry of Municipal Affairs and Housing Ministry and also the Ministry of Transportation and Infrastructure. I've previously encouraged City staff to apply accordingly and have also offered my assistance with any questions they may have in this regard.

With regards to the complaints that the Regional District's elected officials receive with regards to this particular segment of the road, I would suggest that these be redirected to the City of Williams Lake for their review and follow-up accordingly.

Thanks for taking the time to write to express the Regional District's concern and support on behalf of the City.


Re: Dog Creek Road
