**Re: Bus Service to the Cariboo Chilcotin**

Thank you for your letter regarding passenger transportation to the Cariboo Chilcotin. I am sorry it has taken me so long to reply.

We know there is still work left to do to ensure people in rural and remote communities can travel by bus safely, affordably and reliably. As you mention, a private operator, Merritt Shuttle Bus, applied for and was approved to provide service on Highway 97 through the Cariboo. I understand the company experienced start-up challenges with its efforts to launch a privately operated inter-city bus service, and that the Passenger Transportation (PT) Board's approval of the service expired when the company did not start prior to the PT Board's latest deadline. I also understand that the PT Board recently approved an application for two new inter-city bus routes to Cariboo communities that have been without service since Greyhound exited. More information about these routes is available on the PT Board's website at <https://www.ptboard.bc.ca/bus.htm>.

Private bus operators are currently providing service on most of Greyhound's former routes in B.C., and the ministry issued a Request for Expressions of Interest (RFEI) to engage the private sector on solutions to fill the remaining gaps in service. The RFEI has now closed, and we are determining the next steps. At the same time, the ministry continues to participate in an interprovincial working group with the federal government and other provinces and territories to address the impact of discontinued inter-city bus services. I am committed to continuing to work in close partnership with local communities, the private sector and the federal government to develop solutions.

You may be aware that Northern Health Connections has expanded eligibility for its bus service so that seniors and people with mobility challenges who do not have medical appointments can now ride the Northern Health Connections bus. On behalf of my constituents in the Cariboo Chilcotin I am requesting the Passenger Transportation Board open the bidding process for a passenger service in the Cariboo Chilcotin. Since the closure of Greyhound there is absolutely no public offered transportation for residents to Vancouver, Kamloops, and Southern Communities nor to the North.

Many residents of the Cariboo Chilcotin have Doctors' appointments out of the area, now with no means other than the Northern Health Bus which does a great service but is not accessible to all. The region has been stranded. It is my understanding a company from Merritt had been given a license but have no vehicles to provide the service. I heard on media this morning they now have been given an extension as they still cannot deliver a service as they have not obtained funding.

I find it hard to believe a license could be given to a company to provide a service without the equipment to do so.
