Short Summary:

Area F Community Halls – Budget Surplus Allocation to Likely Community Hall

Voting:

Corporate Vote - Unweighted

Memorandum:

Since December 2018, the Likely Community Hall has been unoccupiable due to structural damage, particularly rotting in the main support beams for the floor joints. The hall building is quite old and originally served as a cook shack for the Bullion Pit Gold Mine.

The Area F Community Halls budget supports operating costs at five locations including Likely, Big Lake, Miocene, Horsefly and 150 Mile House. Under the current contribution agreement, each hall receives \$10,000 per year towards core operating costs, such as insurance and utilities. The function also has maintained an adequate budgeted surplus, which was agreed to be accessed in critical unforeseen circumstances such as the needed repairs in Likely. The other Area F Community Halls have agreed via email to the allocation of up to \$10,000 of the function surplus toward the repair works.

The Likely and District Chamber of Commerce obtained a quote from Sprucelee Construction Ltd. estimating approximately \$20,000 for the repair. The Chamber will pursue additional funding through fundraising and other potential grants.

Financial Implications:

The allocation of \$10,000 for the repairs will reduce the 2019 financial plan surplus to an estimated \$20,268 and will have no impact on future requisition or the contribution agreement amounts.
