

CARIBOO REGIONAL DISTRICT

BYLAW NO. 5235

A bylaw of the Cariboo Regional District, in the Province of British Columbia to establish an economic development service for Electoral Area E.

WHEREAS pursuant to the provisions of the *Local Government Act*, a Board may establish services to meet the needs of communities;

AND WHEREAS the Board of Directors of the Cariboo Regional District has deemed it responsible and proper to establish an economic development service for all of Electoral Area E;

AND WHEREAS the Board has deemed it proper and expedient for approval of the electors be given for the participating area by way of written approval of the Electoral Area Director;

NOW THEREFORE the Board of Directors of the Cariboo Regional District, duly assembled, enacts as follows:

1. CITATION

This bylaw may be cited for all purposes as "Cariboo Regional District Electoral Area E Economic Development Service Establishment Bylaw No. 5235, 2019".

2. SERVICE DESCRIPTION

The purpose of the Electoral Area E Economic Development service created under this bylaw is to provide support for projects and activities that improve the local economic situation including but not limited to work in important sectors such as tourism, agriculture, natural resource development and the retention and attraction of businesses and residents.

3. SERVICE BOUNDARIES AND PARTICIPANT

The boundaries for this service shall be the existing boundaries of Electoral Area E of the Cariboo Regional District in its entirety. Electoral Area E shall be the sole participant.

4. COST RECOVERY

All costs associated with this service shall be recovered by way of the following:

- 1. Property value taxes imposed in accordance with Part 11, Division 3 [Requisition and Tax Collection], of the *Local Government Act* on the basis of net taxable value of land and improvements;
- 2. Revenues received by way of agreement, enterprise, gift, grant or otherwise.
