Short Summary:

Request from Director Forseth – Crime Activity in Rural Areas

Memorandum:

Director Forseth has submitted the following:

"As of the writing of this memorandum – crime has been in the news in Electoral Areas A, D, G and H. In addition, Director Bachmeier has reported issues involving crime in Electoral Area B at a previous Board meeting. As this doesn't appear to be getting better, I believe the Board should consider meeting with the 3 RCMP Detachment Commanders from 100 Mile House, Williams Lake and Quesnel to discuss the situation at a Regional Level prior to elevating to North District RCMP or elsewhere, given the regional context involved.

My Electoral Area alone in the last two years has had a number of break and enters in the McLeese Lake and Cuisson Lake areas including this past Labour Day long weekend and my residents are quite insistent on installing video cameras in the community plus installing "Crime Watch signs" in the community of McLeese Lake as well... plus the recently publicly reported break and enters & other criminal activities in Electoral Areas G and H which has resulted in two public meetings in Lac La Hache and the calling for a public meeting by the Williams Lake Tribune on the subject of crime in Williams Lake.

However, prior to meeting with the 3 RCMP Detachment Commanders (should the Board determine that to be an appropriate course of action) – the Board should consider strategizing about where it wants to go with the rising crime levels in the Electoral Areas and what course of action to take (perhaps at a Special Committee of the Whole meeting). I'm not totally convinced more rural money (via the Rural Police Tax) at policing is necessarily going to solve the problem, given the service delivery model the RCMP currently uses for policing in the rural areas but we could meet with the local RCMP Detachment Commanders as part of a research

exercise prior to meeting with Ministers or Provincial Senior Staff or Provincial BC RCMP Sta	ıff
during 2020 including at the September 2020 UBCM Convention in Victoria."
