### **Short Summary:**

Cariboo Regional District Barlow Creek Fire Protection Loan Authorization Bylaw No. 5237, 2019

### **Voting:**

Corporate Vote - Weighted

#### **Memorandum:**

The Barlow Creek Fire Protection Service has a fire engine that needs to be replaced in 2020. Loan Authorization Bylaw No. 5237 is presented for consideration of three readings so that it may be forwarded to the Ministry of Municipal Affairs and Housing for statutory approval, prior to the Board authorizing a public assent process.

Staff's strong recommendation will be to proceed to an Alternative Approval Process (AAP) rather than referendum, as the costs are significantly less and, in this circumstance, taxes will not need to be increased to accommodate the 10-year borrowing, so strong elector opposition is not likely. The last three AAP's that we conducted, which were the same scenario, yielded zero electors submitting Elector Response Forms in opposition.
