Request for CRD Chair Signature on Joint Submission to MOECCS Clean BC – Plastics Action Plan

Memorandum:

The Ministry of Environment and Climate Change Strategy (MOECCS) has recently launched public consultation around the issue of plastics reduction and they have extended their deadline to September 30, 2019.

Numerous regional district and municipal staff members held a conference call on August 14, 2019 to discuss a joint response to the Plastics Action Plan in order to provide the Ministry with harmonized feedback from local governments.

Five topic areas were determined as matters requiring specific feedback from the local government sector. Staff from the District of Squamish and the District of Tofino co-wrote the attached (Attachment #2) high-level letter based on these themes below:

- 1. Prioritization of Reduction and Reuse over Recycling and Disposal
- 2. Clarification of Local Government Authority
- 3. A "Stepped" or Phased Approach to Regulation
- 4. Improvement of Extended Producer Responsibility (EPR) Programs
- 5. Adequate Consultation, including other Ministries

CRD staff strongly support the contents of the letter.
