

CARIBOO REGIONAL DISTRICT

BYLAW NO. 5244

A bylaw to create a new service by merging Bylaw No.'s 3706, 3855, 5016, 5017, and 5235.

WHEREAS a service has been established by the Cariboo Regional District by Bylaw No. 3706, cited as "Cariboo Regional District Electoral Area "F" Economic Development Service Establishment Bylaw No. 3706, 2001";

AND WHEREAS a service has been established by the Cariboo Regional District by Bylaw No. 3855, cited as "Cariboo Regional District Electoral Area "D" Economic Development Service Establishment Bylaw No. 3855, 2003" as amended;

AND WHEREAS a service has been established by the Cariboo Regional District by Bylaw No. 5016, cited as "Cariboo Regional District Electoral Area J Economic Development Service Establishment Bylaw No. 5016, 2016";

AND WHEREAS a service has been established by the Cariboo Regional District by Bylaw No. 5017, cited as "Cariboo Regional District Electoral Area K Economic Development Service Establishment Bylaw No. 5017, 2016";

AND WHEREAS a service has been established by the Cariboo Regional District by Bylaw No. 5235, cited as "Cariboo Regional District Electoral Area E Economic Development Service Establishment Bylaw No. 5235, 2019";

AND WHEREAS the Cariboo Regional District Board deems it beneficial to merge the five economic development services established in the above-mentioned bylaws to provide for one economic development service;

AND WHEREAS consent has been received from at least two-thirds of the participants to merge the five services accordingly;

NOW THEREFORE the Cariboo Regional District in open meeting assembled, enacts as follows:

1. CITATION

This bylaw may be cited for all purposes as the "Cariboo Regional District Central Cariboo and Chilcotin Economic Development Services Merge Bylaw No. 5244, 2019".

2. SERVICE DESCRIPTION

The purpose of the Central Cariboo and Chilcotin Economic Development Service created under this bylaw is to provide support for projects and activities that improve the local economic situation including but not limited to work in important sectors such as tourism, agriculture, natural resource development and the retention and attraction of businesses and residents, within the boundaries of the merged service area to be known as the Central Cariboo and Chilcotin Economic Development Service Area.

3. SERVICE AREA AND PARTICIPANTS

- a) The merged Service Area is all of Electoral Areas D, E, F, J, and K and shall be known as the Cariboo Regional District Central Cariboo and Chilcotin Economic Development Service Area.
- b) The participants in the Cariboo Regional District Central Cariboo and Chilcotin Economic Development Service are Electoral Areas D, E, F, J, and K.

4. COST RECOVERY

All costs associated with this service shall be recovered by way of the following:

- a) Property value taxes imposed in accordance with Part 11, Division 3 [Requisition and Tax Collection], of the Local Government Act on the basis of net taxable value of land and improvements;
- b) Revenues received by way of agreement, enterprise, gift, grant or otherwise.
