



CARIBOO REGIONAL DISTRICT

BYLAW NO. 5255

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to amend the Quesnel Fringe Area Fire Protection Service boundaries.

WHEREAS a service area has been established by the Cariboo Regional District by Bylaw No. 2979, cited as “Red Bluff Fire Protection Local Service Establishment Bylaw No. 2979, 1995”;

AND WHEREAS Bylaw No. 2979 was amended by merging “Two Mile Flat Fire Protection Service Establishment Bylaw No. 4760, 2012” into Bylaw No. 2979, through the adoption of “Quesnel Fringe Area Fire Protection Service Bylaw No. 4979, 2015”;

AND WHEREAS the Cariboo Regional District Board has been petitioned by owners of a property who wish to join the Quesnel Fringe Area Fire Protection Service;

AND WHEREAS the Board has deemed it in the interest of providing good government to expand the boundaries of the Quesnel Fringe Area Fire Protection Service to include the subject property;

NOW THEREFORE the Board of Directors of the Cariboo Regional District, duly assembled in open meeting, hereby enacts as follows:

1. Title

This bylaw may be cited for all purposes as “Quesnel Fringe Area Fire Protection Boundary Expansion Bylaw No. 5255, 2020”.

2. Amendment

Schedule A, which forms part of Bylaw No. 2979, is hereby deleted in its entirety and replaced by Schedule A, attached to and forming part of this bylaw.
