Short Summary:

Proposed Sugarcane Firehall

Memorandum:

It was brought forward to staff to explore the feasibility of a second firehall in the 150 Mile Fire Protection District located in Sugarcane adjacent to Highway 97 in a former tire shop. Staff worked in conjunction with the CAO of Williams Lake Indian Band to look at expectations and what would be required in regard to upgrades of the existing proposed building, capital purchases, and ongoing operational costs for this venture. Additionally, what impacts this would have to the level of service and benefit(s) to the regional district.

Once a clear picture was created, CRD staff set out a reasonable budget to capture what the financial impact would be. Attached is what staff believe to be an accurate accounting of impact to the operational and capital budget for the fire district. Based on the required amount, this would have to go to referendum for the ratepayers.

It is the opinion of staff that the construction of a new hall would have a negative impact to the wellbeing of the fire district. Firstly, the construction of a new hall would have zero reduction on insurance ratings as it would be within the existing eight-kilometer travel distance to the primary hall. Secondly, it would compete with the existing hall for members and resources, thus creating administrative burden for the organization. Because of these two factors, a cost benefit analysis determines that this project should not proceed and be abandoned.
