



CARIBOO REGIONAL DISTRICT

BYLAW NO. 5280

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to establish a service to provide streetlights in the Maple Drive area of Electoral Area A.

WHEREAS, pursuant to provisions of the *Local Government Act*, a Board may, by bylaw, establish services for the use and benefit of all or part of the Regional District; and,

WHEREAS, the Board has deemed it in the best interest of the Regional District to establish a service within Electoral Area A to provide a streetlighting service in the Maple Drive area; and,

WHEREAS, the Board of the Cariboo Regional District has obtained the approval of the service area electors by the alternative approval process in accordance with Section 345 of the *Local Government Act*;

NOW THEREFORE, the Board of Directors of the Cariboo Regional District, duly assembled in an open meeting, enacts as follows:

1. CITATION

- a) This bylaw may be cited for all purposes as “Cariboo Regional District Maple Drive Streetlighting Service Establishment Bylaw No. 5280, 2020.”

2. DESCRIPTION OF SERVICE

- a) This service will allow the installation and maintenance of streetlights in the Maple Drive area as defined by Schedule “A” attached to and forming part of this bylaw.
- b) This service shall be referred to as the “Maple Drive Streetlighting Service.”

3. SERVICE BOUNDARIES/PARTICIPANTS

- a) The boundaries of the Maple Drive Streetlighting Service Area are as defined in Schedule "A" attached to and forming part of this bylaw.
- b) The Maple Drive Streetlighting Service is solely contained within Electoral Area A, and Electoral Area A is the sole participant.

4. COST RECOVERY

- a) All costs associated with this service shall be recovered by way of:
 - i. Property value taxes imposed in accordance with Division 3 *{Requisition and Tax Collection}* of the *Local Government Act*;
 - ii. Revenues received by way of agreement, enterprise, gift, grant or otherwise.
- b) The maximum amount that may be requisitioned for this service shall be \$9,000 per year or an amount recovered by applying a tax rate of \$0.0741/\$1,000 per year to the net taxable value of lands and improvements.
