

CARIBOO REGIONAL DISTRICT

BYLAW NO. 5280

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to establish a service to provide streetlights in the Maple Drive area of Electoral Area A.

WHEREAS, pursuant to provisions of the *Local Government Act*, a Board may, by bylaw, establish services for the use and benefit of all or part of the Regional District; and,

WHEREAS, the Board has deemed it in the best interest of the Regional District to establish a service within Electoral Area A to provide a streetlighting service in the Maple Drive area; and,

WHEREAS, the Board of the Cariboo Regional District has obtained the approval of the service area electors by the alternative approval process in accordance with Section 345 of the Local Government Act;

NOW THEREFORE, the Board of Directors of the Cariboo Regional District, duly assembled in an open meeting, enacts as follows:

CITATION

a) This bylaw may be cited for all purposes as "Cariboo Regional District Maple Drive Streetlighting Service Establishment Bylaw No. 5280, 2020."

DESCRIPTION OF SERVICE

- a) This service will allow the installation and maintenance of streetlights in the Maple Drive area as defined by Schedule "A" attached to and forming part of this bylaw.
- b) This service shall be referred to as the "Maple Drive Streetlighting Service."

3. SERVICE BOUNDARIES/PARTICIPANTS

READ a first time this ___ day of _____, 2020.

- a) The boundaries of the Maple Drive Streetlighting Service Area are as defined in Schedule "A" attached to and forming part of this bylaw.
- b) The Maple Drive Streetlighting Service is solely contained within Electoral Area A, and Electoral Area A is the sole participant.

4. COST RECOVERY

- a) All costs associated with this service shall be recovered by way of:
 - i. Property value taxes imposed in accordance with Division 3 {Requisition and Tax Collection} of the Local Government Act;
 - ii. Revenues received by way of agreement, enterprise, gift, grant or otherwise.
- b) The maximum amount that may be requisitioned for this service shall be \$9,000 per year or an amount recovered by applying a tax rate of \$0.0741/\$1,000 per year to the net taxable value of lands and improvements.
