## **Short Summary:**

Bouchie Lake Community Hall Community Works Funding (CWF) Energy Efficiency Project

#### **Voting:**

Corporate Vote - Unweighted

#### Memorandum:

A request for up to \$20,300 of Community Works Funding was received from the Bouchie Lake Recreation Commission to perform a lighting upgrade at the Bouchie Lake Community Hall and grounds.

The lighting upgrade will involve replacing all exterior lighting on the hall property and all interior hall lighting with energy efficient LED lights. It is expected the upgrade will result in energy savings of approximately 11,300 kWh/year.

The Bouchie Lake Community Hall is owned by the Regional District and therefore no contribution agreement is required.

### **Financial Implications:**

The proposal from the Bouchie Lake Recreation Commission requests up to \$20,300 from the Community Hall Improvements envelope of the 2020 CWF program.

The Board approved the CWF funding schedule for 2020, including the Community Hall Improvements envelope which originally had a total of \$150,000 available. If this application from the Bouchie Lake Recreation Commission is approved, \$20,300 will be committed through the Community Hall Improvements envelope, leaving a balance of \$79,270 available for community projects.

## **Policy Implications:**

None. The Board approved the CWF funding schedule for 2020, including the Community Hall Improvements envelope. This project meets CWF criteria for Energy Efficiency projects.
