Short Summary:

Request from Director Forseth - Propose Merging Economic Development Services

Memorandum:

Director Forseth has submitted the following background information for the Board's discussion and consideration with regard to merging the North, Central Cariboo/Chilcotin and South Economic Development Services as one CRD function:

"The Cariboo Regional District currently has 3 sub-Regional Economic Development Services in North Cariboo (all of Areas A,B,C,I); Central Cariboo/Chilcotin (all of Areas D,E,F,J,K) and South Cariboo (all of Areas G,H,L)

By way of history — North Cariboo established their Economic Development Service in 1992, South Cariboo established their Economic Development Service originally in 2000 (modified in 2004 to remove Area H and modified again in 2007 to include Area H in this Service once again) and Central Cariboo/Chilcotin created their merged Economic Development Service just last year (2019). Central Cariboo/Chilcotin & South Cariboo Economic Development Services currently have no tax requisition limits whereas North Cariboo currently has a tax requisition limit of -- Greater of \$10,000 or applying a tax rate of \$0.0257 per \$1,000 of assessment on the basis of land/improvements.

As the Board is aware, the Board's Strategic Plan, does calls for like individual services, where appropriate, to be merged into a single RD Service. As well, progress to fund a Regional Broadband Strategy (CRD & Government of BC through NDIT) has been hindered, in part, due to identifying a source of local funding. Normally, Economic Development would be a good fit for a Regional Broadband Strategy exercise except North Cariboo has a requisition limit and expenditures in North Cariboo Economic Development is very close to the requisition limit vs Central/South Cariboo Economic Development Services which has no requisition limits. 1 Merged Economic Development Service would be desirable for stable tax requisition for a similar

service across all Electoral Areas and help to reduce taxation levels across the Electoral Areas, both for this potentially combined Economic Development Service and all RD Services

The 3 Economic Development Services do have similar Business Plan Goals including support for local Visitor Information Centres in Quesnel, Williams Lake and 100 Mile House as well as support for community development for the unincorporated communities within in the 12 Electoral Areas

I would request the Board authorize Staff time to bring back a report to outline options merging the sub-Regional Economic Development Services into 1 Regional Service and the pros/cons in doing so..."
