Low Mobility Wilderness Trails Network Expansion Project - Investing in Canada Infrastructure Program Grant Application

# Memorandum:

On June 25, 2020, the federal and provincial governments announced a second intake for their joint capital infrastructure grant programs including three funding streams: Community, Culture and Recreation (CCR), Rural and Northern Communities (RNC), and a newly-announced COVID-19 Resiliency envelope.

Following the discussion and direction provided at the Cariboo Regional District Committee of the Whole meeting on August 20, 2020, an application for CCR program grant funding has been developed for a low mobility wilderness trails network expansion project. The ICIP-CCR aims to improve access to and/or increase quality of cultural, recreational and/or community infrastructure for Canadians.

This project would be eligible for grant funding of up to 73.33% of the project costs under the ICIP-CCR component, which has an intake deadline of October 1, 2020. Numerous trail projects were approved in the first round of the ICIP program and in general these applications appear well-positioned to meet the priority objectives for the grants.

An applicant may apply to more than one of the ICIP components for the same project; however, the project will only be funded through one program. The ICIP also has a new temporary COVID-19 Resilience stream available within existing funding that could also be appropriate to the project when the funding stream becomes available.

The Regional District has embraced creating a wheelchair accessible trails network in the Cariboo Chilcotin to increase outdoor recreation opportunities for people of all mobility levels and to create a niche market for tourism to help diversify the local economy.

Primarily through external funding from the Government of British Columbia, Northern Development Initiative Trust, and Cariboo Strong, 25 wheelchair accessible wilderness trails have been completed since 2008 and three more are currently in development in 2020 with \$130,000 in support from Rural Dividend and NDIT grants.

These three new proposed trail projects for the CCR grant program would be significantly larger in scope than previous projects completed by the Regional District, but with the same lowmobility, universal access concept. The locations include Pioneer Park on Dragon Lake, the Esler Sports Complex and the 108 Greenbelt. The combined projects will provide about 8 km of trail works, along with ancillary improvements for parking, signage, toilets and potentially wheelchairfriendly fishing platforms. These properties were selected in part because the Region owns the lands and has direct or partnership arrangements for maintenance, which makes investments on this scale more feasible.

A project coordinator retained on a contract basis will be necessary to procure and coordinate construction, provide guidance and confirm delivery on standards, and to assist in meeting grant program reporting requirements. The cost for a project coordinator is included in the grant funding application.

# **Financial Implications:**

The proposed project has a total value of \$458,200. The CCR grant application for 73.33% of the cost will amount to \$336,000 with a remaining matching requirement of \$122,200.

A grant application for the full amount of the matching funding will be submitted to the October 30, 2020 intake of the Northern Development Initiative Trust.

However; to improve the chance of CCR grant approval, confirmed funding from sub-regional recreation functions including North Cariboo Recreation and Parks, Central Cariboo Recreation and Leisure Services and South Cariboo Recreation and Culture functions is proposed to be committed in the 2021 financial plan. This will amount to \$40,700 per sub-regional recreation function and can be integrated, in part, with other trail project funding already included in the recreation budgets.

# **Policy Implications:**

The Low Mobility Wilderness Trails Network Expansion Project was chosen for an Investing in Canada Infrastructure - Community, Culture and Recreation Program application as the project

meets identified regional strategic and business plan goals and is expected to have a good chance of success based on grant program criteria.
