BYLAW NO. 5239

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to establish a service within a portion of Electoral Area G for the purpose of providing a public parking area that can be utilized by the owners of property on Emerald and Crown Royal Islands on Lac La Hache.

WHEREAS, pursuant to the provisions of the *Local Government Act*, a Board may establish services for all or part of its jurisdiction;

WHEREAS, the Regional District has received a request from the property owners on Emerald and Crown Royal Islands to facilitate the development of a public parking space that could be used by property owners on Emerald and Crown Royal Islands when they visit their boat-access-only properties;

AND WHEREAS the Board of the Cariboo Regional District has obtained the approval of the electorate within the Emerald/Crown Royal Island Parking Service Area by petition in accordance with Section 337 of the *Local Government Act*;

NOW THEREFORE, the Board of the Cariboo Regional District, duly assembled in an open meeting, enacts as follows:

1. Establishment

The Cariboo Regional District hereby establishes within a portion of Electoral Area G a service to provide for a public parking area on Lac La Hache. This service shall be known as the Emerald/Crown Royal Island Parking Service.

2. Purpose of the Service

The purpose of this service is to develop, ensure and enable the maintenance of a public parking lot on a Provincially owned parcel on Lac La Hache, that can be used by the property owners of Emerald and Crown Royal Islands in Lac La Hache, albeit without any rights to exclusivity. (See Schedule 'B')

2. Service Area and Participant

- a) The boundaries of the service area are shown outlined on the plan attached as Schedule 'A', attached to and forming part of this Bylaw, and are known as the "Emerald/Crown Royal Island Parking Service Area".
- b) The participant of the Emerald/Crown Royal Island Parking Service is Electoral Area G.

3. Cost Recovery

- a) The annual costs for the service shall be recovered by one or more of the following:
 1. parcel taxes imposed in accordance with Part 11: Division 3 of the *Local Government Act (Requisition and Tax Collection)*;
 2. fees and charges imposed under section 397 of the *Local Government Act (Imposition of fees and charges)*;
 3. revenues raised by other means authorized by the *Local Government Act* or another act; and/or
 4. revenues raised by way of agreement, enterprise, gift, grant or otherwise.
- b) The maximum amount of money that may be requisitioned in any one year for the service provided in Section 1 of this bylaw shall not exceed \$4,000.00.

4. Citation

This bylaw may be cited for all purposes as the "Emerald/Crown Royal Island Parking Service Establishment Bylaw No. 5239, 2019".

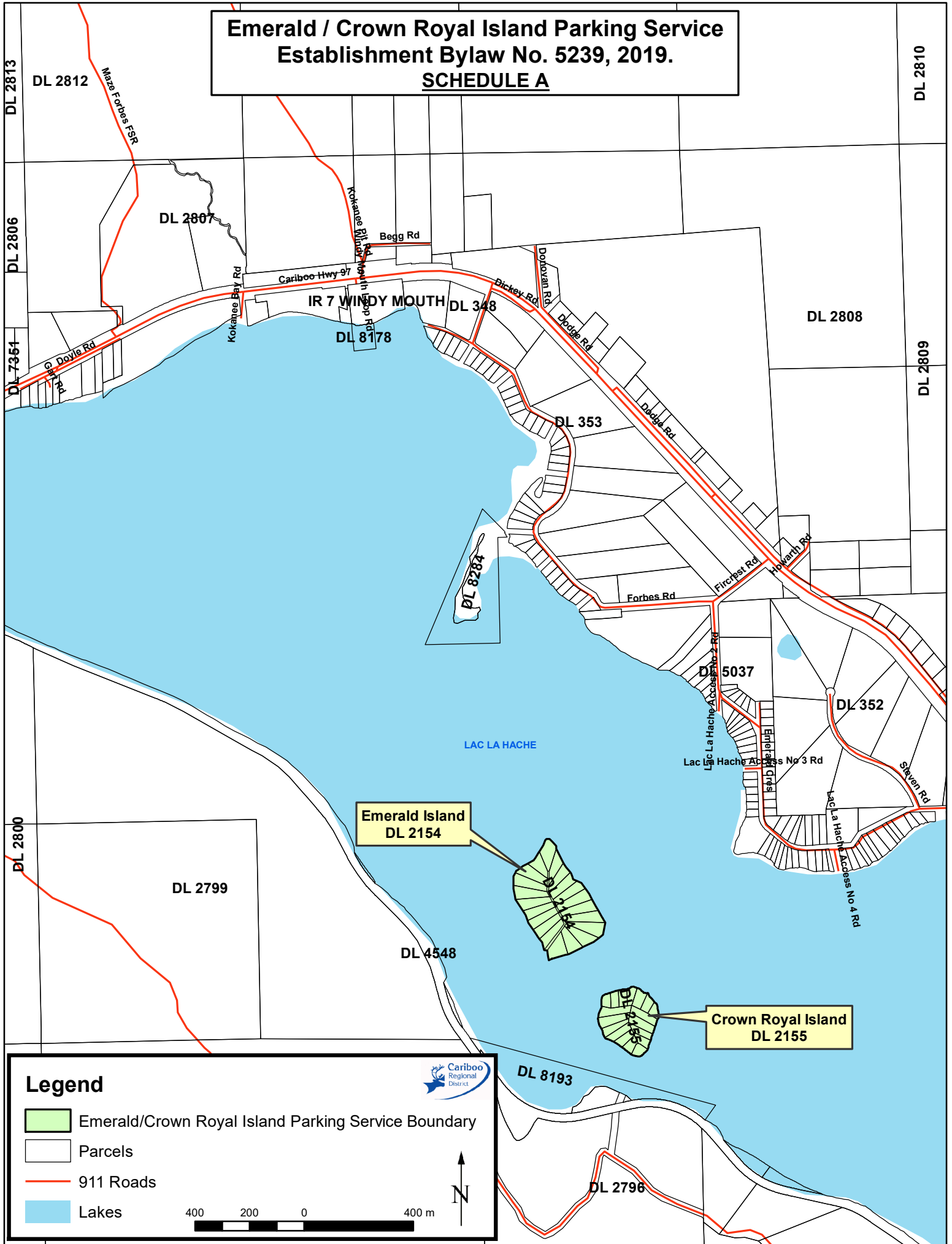

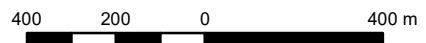
