## Short Summary:

Joint Use Agreement Between School District 27, Thompson Rivers University, City of Williams Lake, District of 100 Mile House and Cariboo Regional District

## Memorandum:

The Board passed the following resolution at its July 10, 2020 meeting:

*"That the agenda item summary from Darron Campbell, Manager of Community Services, dated July 2, 2020, regarding a renewal of the Joint Use Agreement between School District 27, Thompson Rivers University, City of Williams Lake, District of 100 Mile House and the Cariboo Regional District, be referred to the South and Central Joint Committees."*

The AIS was subsequently referred to the joint committees, and the following resolutions were passed.

### Central Cariboo Joint Committee September 16

*"That the agenda item summary of Darron Campbell, Manager of Community Services, Cariboo Regional District dated July 2, 2020 regarding renewal of the Joint Use Agreement between School District No. 27, Thompson Rivers University-Williams Lake Campus, the City of Williams Lake, the District of 100 Mile House and the Cariboo Regional District be received; and further, that the terms be renewed for an additional three years, effective January 1, 2020 to December 31, 2022, and the appropriate signatories be authorized to enter into the Agreement."*

### South Cariboo Joint Committee September 17

*"That the agenda item summary from Darron Campbell, Manager of Community Services, dated July 2, 2020, regarding a renewal of the Joint Use Agreement between School District 27, Thompson Rivers University, City of Williams Lake, District of 100 Mile House and the Cariboo*

*Regional District, as referred to the South and Central Joint Committees by the CRD Board at its meeting on July 10, 2020, be received. Further, that the terms be renewed for an additional three years from January 2020 to December 2022 and the appropriate signatories be authorized to enter into the agreement.”*

In light of the resolutions passed by the Joint Committees, the agreement is now being brought forward to the Board for consideration of approval.
