## **Short Summary:**

Funding Schedule for 2021 and 2022 Replacement of Transtor Waste Bins

### **Voting:**

Corporate Vote - Weighted

#### Memorandum:

Rollins Machinery is the BC supplier for Transtor waste bins. The CRD has requested a quote from Rollins for the purchase and installation of 9 to 11 bins spread between 2021 and 2022.

The attached quote lists a price of \$109,030 per bin plus installation, freight and taxes, but this is based on October 2020 cylinder and steel prices.

Rollins is proposing the CRD lock in the 2020 pricing by committing in writing to the purchase by November 30, 2020 and providing a down payment of \$300,000 by January 15, 2021. This would allow the fabricator to order the required steel and cylinders at the October price and construction would commence in January 2021. It is estimated that this would save the CRD \$60,000.

Transtor waste bin costs were included in the preliminary budget, but final approval of the CRD budget will not occur until March 2021, thus staff are requesting the Board approve this commitment and funding timeline.
