APC Mileage/Honorarium/Long Distance Phone Charges Policy No. 2015-11-34(15) allows for the CRD to reimburse each area Director to a maximum \$35 per person to take Advisory Planning Commission (APC) members and their spouses for an annual recognition dinner.

Director Bachmeier has requested waiving the policy to permit the purchase of a \$70 gift for each member/spouse for the Area "B" APC, or allow for a dinner, depending on COVID-19 restrictions/recommendations in place in December.

Further, Director Bachmeier would also like to include the same recognition for two additional members, which along with most of the Area "B" APC members, form the Bouchie-Milburn Neighbourhood Plan (BMNP) Steering Committee.

Financial Implications:

Area "B" APC and BMNP Steering Committee membership totals ten members between the two groups. Including spouses, the request is for a total of \$700. Of this \$700, \$560 would normally be available through the current APC Policy for annual dinner expenses.

Policy Implications:

The request is a relatively minor waiver from the current APC Mileage/Honorarium/Long Distance Phone Charges Policy D4.1.
