Our regular activities will be funded by entrance fees collected at future events. In 2018 and 2019 we held large provincial 3d championships and were able to solicit donations and have built our bank account to \$23,400. We would like to obtain funds to hold an indoor event that necessitates renting a venue at great expense (\$4,600) but will also bring hotel rentals and restaurant traffic to our area as the event will be held before camping season starts.

Brief Description of Proposed Use of Grant Being Applied For:

We would like to have the CRD Grant cover the rental fees being charged by the City of Williams Lake for the venue. This is a 3 day event (Setup and practice Friday, competition Saturday and competition Sunday). Rental charges for the 2020 event were quoted at \$4600 and we anticipate a similar charge for the 2021 event (if not more for standard inflation) or if we need to secure the second rink in order to maintain social distancing while enabling as many participants to attend as possible.

How do you know there is a need for this service/project in our community?

Williams Lake archers have had tremendous success over the past several years at target and 3d events and it has always required extensive travel. We want to showcase our archers' talents while showing off our town and bringing tourism dollars into our somewhat depressed community, especially in the "off" season after winter sports like hockey and sking and before outdoor summer sports like soccer & baseball.

The President is Lee Jackman, Treasurer Al Campsall, outgoing secretary is Mary Thurow and new secretary is Becky Waterhouse.

Our financial statement is signed by outgoing Secretary Mary Thurow (as the Treasurer Al Campsall is away hunting).

2. Fee Structure

The Cariboo Archers is "a club within a club" as all members are also members of the Williams Lake Sportsman's Association. We do maintain our own bank account but give 50% of annual profits to the WLSA as the facility is technically owned by the WLSA. We therefore don't charge members any additional fees to become Cariboo Archers members in addition to their WLSA membership. Event fees differ from event to event and for the variety of ages of our competitors but can be estimated at between \$6 per flatfield 3d round per person to \$80 per adult competing at a Provincial event, when a youth at that same event would be charged \$50. We endeavour to cover our costs through serious adults and promote the sport for our youth by keeping their costs low. At some smaller 3d events we would charge \$60 for a family so that all are encouraged to participate.

Who we serve

We have mostly served local archers (100 Mile to Quesnel) but we are expanding to serve archers from around the entire province, as well as Alberta & Yukon. Prior to cancelling our 2020 Provincials event we had received registrations from approximately 15 Yukon archers.

7. Do we use CRD-owned facilities?

No not for our regular events (3d shoots and kids JOP program) as we have a small indoor facility and extensive outdoor grounds on Bond Lake Road as part of the Williams Lake Sportsman Association. For this 2021 larger event we will be renting an ice-less hockey rink from the City of Williams Lake at an estimated rental cost of \$4600.

Project Summary Questions.

3 & 4 Other levels of government funding?

No, we are not pursuing other grant applications at this time. We secured a \$1000 grant from ViaSport BC in 2019 for the 2020 event but because it was canceled in February 2020 we were permitted to roll that over to help with our 2021 event. As we are still in the preliminary planning stages for the 2021 event, we do not know whether or not we will pursue other funds.

7. Key activities and associated timelines

Online and paper Registration forms will be built and distributed/posted online in January 2021.

Information packages including host hotels will be made available in February.

Registrations will be replied to and confirmed as they arrive and up until 1 week prior to the event – no registrations on the day-of will be accepted.

Schedules will be created and & distributed to participants in the week before the event.


The event closes with awards Sunday afternoon April 4th.

9. Measuring and evaluating success and impact on the community

This project has the potential to positively impact the community's archers (by providing a high caliber competition close to home), as well as positively impacting the community's business (by bringing in out-of-town archers to contribute to our economy and see how great the Cariboo is.

We will be able to assess success by analyzing our registration list - how many locals participated, how many of those hadn't previously attended a major competition before? How many out-of-town guests came and what did their survey responses indicate of their time in Williams Lake? Success will also be visible, indirectly, over time as people continue to take up the sport and become new or more-dedicated Archers.

There may also be the opportunity to host the 2022 event as communities usually host 2 years back-to-back so if the volunteers feel it was successful, we may submit a bit to the BC Archery Association to host another year. We will be building the capacity of our volunteer base and expanding the Cariboo's exposure as a fantastic place to live, work & play. Thank you for considering our application.

Our expectation had been to spend a significant amount of last year's account total to purchase new targets for the 2019 BC 3D Championships we hosted on the June 22/23 weekend. We did spend \$11,601.99 on new wall targets downstairs and manynew 3D targets. We also purchased a SeaCan for storage (\$3000.00).

Regarding target wear and tear, it is roughly calculated by how many shooters attended. Here are the actual amounts used for the last five years.

- 2019 \$4000.00 for Flatfield and BC Championships Actual expenditure for this year - \$8601.99
- 2018 \$3500.00 for Flatfield and BC Championships Actual expenditure for this year - \$10,615.71
- 2017 \$2300.00 for for Flatfield and Outdoor Actual expenditure for this year -\$2451.52
- 2016 \$2500.00 for Flatfield, Outdoor and Hunter Warm-up Actual expenditure for this year - \$462.00
- 2015 \$1000.00 for Indoor and Outdoor No money spent on targets

So, the amount calculated for 2015-2019 was \$13,300.00 and the actual expenditure was \$22,131.22. Because we are trying to calculate actual wear and tear on targets, it is a guessing game at best. Who is to say which target(s) are worn out more than others? We have bolstered our target inventory considerably in the past five years.

Trending! Our account balance has varied year to year, but is trending upward. However, calculating our huge target costs makes it difficult to properly quantify. Here are the actual balances for the last seven years. Costs per year vary greatly!

Recent shoot feedback: Cariboo Archers received many accolades for our team work in hosting another fantastic BC 3D Championships (this included many positive comments as well as an award for our inventive shot variety). Many people said that they had never been to a better run shoot than the 2018 Championships until they attended the 2019 Championships - well done crew!

D) New Business and Updates

- 1) Cariboo Archers Shoots for 2020 to be decided at the next Executive meeting.

 Fun 3D shoot for members only (no out-of-town shooters; as per PHO Covid-19 plan), combined with 720?

 Suggested date of July 25/26th, Friday 6pm 720 shoot and Saturday 3pm for 720 with 3d anytime Saturday/Sunday. We would need to tear down 720 on Saturday evening to allow for IPSC Sunday access. Weekend was booked at the meeting through Barry Jenkins. Discussion on discouraging out-of-towners / allowing first 50 to sign up / keeping quiet until we confirm its actually happening to have as many locals compared to guests to reduce Covid exposure. *Have we booked judges for 720 portion? *Al / Stu?
- 2) Due to Covid-19, the BC Indoor Target Championships were cancelled. We are again slated to host on April 2-4, 2021.
- 3) Ladies Only Archery and Gentlemen Only Archery nights. Four nights for each were hosted this past season with 14 men and 15 women attending.
- 4) Membership in the Williams Lake Sportsmen's Association is a necessity. Those not paid up will not be allowed to shoot at the facility for two reasons. First, for liability reasons and secondly that they are shooting for free while the rest of the members pay. Money from memberships is used for improvements to the club etc. New potential members will be allowed to shoot for one month (commencing their first time shooting) before they will be required to join to continue shooting. If your membership dues are not current, you will not be eligible to vote today if there are any elections.
- 5) The JOP program run by the WLSA is looking for a certified coach if any archers are interested, please contact Bob Thurow or Lee Jackman. Right now, only Melanie McComber has been certified as a coach for Beginner Archers, has completed Making Ethical Decisions, and has a current Criminal Records Check. She just needs to complete the Range Safety Officer training which should happen in the near future.

E) Election of Officers—Eleven positions are up for re-election. The rest were elected for two year terms in 2019, although Darren will not be staying on.
