Short Summary:

CRD 2020 Financial Plan Amendment Bylaw No. 5263(1), 2020 - A Bylaw to Recognize Amendments During the Year to the 2020 Financial Plan

Voting:

Memorandum:

Over the course of the year, amendments were made to the 2020 Financial Plan; the attached Schedule A reflects these amendments. In total, five amendments were approved by the Board:

- A change in user fees for the Lac La Hache Water system.
 The user fee increase was still in public consultation at the time the budget was adopted. The amended budget reflects the rate increases that were arrived at through the public consultation process.
- An allocation of Community Works Funds to cover increased costs of Transtor Bins at the Alexandria transfer station (\$100,000).
- An allocation of Community Works funds to cover costs associated with preparing for reopening CRD facilities in the COVID-19 environment (\$100,000).
- An allocation of funds to the recreation functions to cover the costs of COVID-19 proofing the facilities for reopening in the COVID-19 environment (\$50,000).
- An allocation of Community Works Funds to Rural Feasibility to fund a Regional Broadband Study (\$80,000) and reversing an amount allocated to Electoral Area Administration of \$120,000 of Community Works Funds for this purpose.
- Lastly, prior year's surpluses have been adjusted to reflect 2019 actual ending values which were not available at the time Bylaw 5263 was adopted.

In total, these amendments add up to an increase in revenue of \$213,676 for an overall increase of 13% from what was approved in the 2020 Financial Plan. Similarly, expenses are budgeted to increase by the same amount. Bylaw 5263(1) is being brought before the Board for approval to formally recognize these amendments to the 2020 Financial Plan.
