Short Summary:

Horsefly Community Club - Community Works Funding Request for Hall Water System

Voting:

Memorandum:

The Horsefly Community Club has requested a Community Works Funding contribution of up to \$5,545 to continue to improve the drinking water system at the Horsefly Community Hall.

The Horsefly Community Hall's water supply is from a new well dug in 2020 with a contribution from the Regional District through the CWF program. Now that the new well is in place and providing adequate amounts of potable water to the hall, additional upgrades are required. The Community Club would like to run new insulated water lines to the kitchen and bathrooms. The current lines are over thirty years old and the bathrooms have never had hot water. The bathrooms will also be equipped with automatic, electronically controlled hands-free faucets. Additionally, a large water softener and a reverse osmosis system will be installed to produce top-quality drinking water.

Because the community hall is not owned by the CRD, a contribution agreement between the Regional District and the Horsefly Community Club is required for this project by UBCM under its Gas Tax Sharing Master Agreement with the federal government. Under the terms of the agreement, the community group is responsible for managing the project, maintaining financial records, reporting on measurable results and retaining ownership of the asset for a minimum of 10 years.

Financial Implications:

The proposal from the Horsefly Community Club requests up to \$5,545 from the Community Hall Improvements envelope of the 2021 CWF program.

The Board approved the CWF funding schedule for 2021, including the Community Hall Improvements envelope which has a total of \$150,000 available. If this application from the Horsefly Community Club is approved, \$5,545 will be committed through the Community Hall Improvements envelope, leaving a balance of \$144,455 available for community hall projects.

Policy Implications:

None. The Board approved the CWF funding schedule for 2021, including the Community Hall Improvements envelope. This project meets CWF criteria for developing drinking water systems.
