#### Memorandum:

Put forward as a strategic objective of the 2020 -2022 Strategic Plan, the Finance Department committed to producing Standardized Financial Reports on a regular and timely basis.

The reports are generated to provide the Board, the organization and the public with a regular source of information of the CRD's operations.

The current report covers the period of January 1 – September 30, 2020. The operating results of the CRD Services are given providing a comparison of the annual budget amounts to actual revenue and expenses along with the prior year actual results.

The reports show that services are where they should be at this point in the year. Most services are running close to budget with some showing increased surpluses due to reduced activity as a result of COVID-19 restrictions, predominantly in Protective Services.

Readers are cautioned that the results presented may change significantly in the last quarter as many services have contracts that get paid out at the end of the year, missed payments are found, and adjustments are made in preparation for yearend.
