1. What plans has your organization made to fund its activities over the next 3-5 years?  
**Our funding is currently provided by membership and administration fees; individual's session fees; program fees, grants, sponsorships and fundraising. We try our best to keep the cost of our services as low as is feasible so the children can receive as much assistance as possible.**

**The process is underway for the organization to open a Community Child Care facility in January 2021. The building we have acquired will provide space for childcare for 24 - 0 to 30 months, 24 -30 months (2.5) to school age, and 24- kindergarten to 12 years of age in an afterschool program. These spaces will be reserved as: 50% of these spaces will be reserved for children with special needs, 25% of the spaces will be for neurotypical ("normal") children and 25% of the spaces for the New Horizons' childcare and office staff and students enrolled in the Early Childhood Educator (ECE) and Behavioural Interventionist programs. The building will also provide revenue rental to other community organizations.**

2. If your organization charges user fees/memberships/admission, attach your current fee structure:

**Memberships: Over 6- \$35/month; Under 6 -\$60/month; and Homeschool/Unschool- \$85/month.**

3. What are your organization's specific goals and objectives for this year? How do they differ from previous years?

**Our organization's specific goals and objectives for 2021 is to have the childcare operational to full capacity, increase Awareness of Autism and other diverse needs within our communities and continue to support these vulnerable people and their families.**

4. Who does your organization serve?

**Our organization serves the communities surrounding Williams Lake including south of 100 Mile House and north towards Quesnel. We provide services to anyone that requires support for themselves or a family member, from 0 to 99+ years, whether they are diversely-abled or not.**

5. Does your organization receive a rental subsidy from the CRD? If so, how much? **No**

1. Brief Description of Proposed Use of Grant Being Applied for:

**We are proposing to use the requested funds to provide any “First Responder”; volunteer Fire Departments, Search & Rescuers, Ambulance Attendants and Police Officers; with the tools to understand the needs and help a person with Autism Spectrum Disorder, and other diversely-able people, in the event of a traumatic incident, e.g. vehicle accident, fire, lost, etc. Canucks Autism Network (CAN) has a program that supports the first responder community by providing training that aims to increase confidence and effectiveness of responses in situations involving an individual with autism.**

**We had intended to bring the in-person training to our area in April of 2020, however the pandemic interfered. CAN now provides the training Live through ZOOM so each First Responder “cohort” can still receive the training but in a smaller group setting such as their own training facility. Or we can make arrangement to use New Horizons Society or another facility, if they do not have online capabilities at their units’ location.**

2. How do you know there is a need for this service/project in our community?

**I. Statically individuals with autism are seven times more likely to interact with first responders, than a Neurotypical person.**

**II. Roughly half, or 48%, of children with an ASD attempt to elope from a safe environment, a rate nearly four times higher than their unaffected siblings**

**III. More than one third of ASD children who wander/elope are never or rarely able to communicate their name, address, or phone number**

**IV. Drowning is among the leading causes of death of individuals with autism.**

**V. When we originally opened under the other organization a number of members of the Central Cariboo Search & Rescue, 150 Mile Fire Department and the Williams Lake Fire Department had asked for information on how to handle situations with children with Autism.**

3. Is your agency applying for funds from other levels of government or other sources for this project?

**We are requesting funds from South Cariboo –District of 100 Mile House and Quesnel Community Foundations, Vancouver Foundation, Prince George Community Foundation (both these foundations receive funds to distribute to other regions in the province).**

**If funds applied for are not received. we may need to charge the individual participants registration fee; we would only do this once we exhausted other funding avenues such as local businesses.**

April of 2019, Crystal Turatus, required a Behavioural Consultant for her 3-year-old newly diagnosed with Autism Spectrum Disorder (ASD) child. She obtained one in Kamloops, BC, at New Heights Autism Support Society (NHASS). After discussing the limited resources and support in Williams Lake and the surrounding communities, Crystal agreed, in August 2019, to help the Behavioural Consultant (BC) open an office similar to the one in Kamloops, in Williams Lake.

As the office was being set up in September, inquires were already being made of the services being provided by NHASS. On October 17<sup>th</sup>, 2019, the organization held a Soft Opening of its Outreach Office in Williams Lake to work parallel and collaborate with other like-minded organizations in the Williams Lake community and beyond. Based on the information gathered from parents/caregivers, community professionals and like-minded organizations that attended the soft opening, the Outreach Office begun its plan of action.

By the end of October 2019, there were 39 children registered at NHASS. The Kamloops organization was not prepared for the volume of need in Williams Lake, and surrounding communities and 100 Mile House area. Unbeknown to Crystal, NHASS was issues with their staff and could/would not provide appropriate financials required by the Grant Writer. In November 2019, NHASS decided not to continue in Williams Lake.

By this time the community had embraced the concept of the Outreach office and the services it was offering. Crystal and her mother, Betty, decided to continue the concept under a new not-for-profit society. They were able to gather community members to become a diverse Board of Directors. On December 19, 2019, New Horizons Society for Autism & Special Needs became an incorporated Society in the province of British Columbia. On January 6, 2020, New Horizons Society for Autism & Special Needs officially opened.

Between November, 2019, when New Heights Autism Support Society removed themselves from the community and January 2020, when New Horizons Society for Autism & Special Needs officially became opened, services to the parents and children continued under New Horizons Society for Autism & Special Needs.

In essence, the clients from September and October 2020, have always been served by Crystal, Betty and their team just under a different name. Unfortunately, as the financials were held under NHASS until we could get all the official paperwork together, New Horizons Society does not have past financials.

We also do not have official AGM meeting minutes as the inaugural board has been setting the organization up from scratch. Our first AGM is scheduled for December 19, 2020.

September 1, 2020:

New Horizons Society now has 151 clients that we provide support to. This support includes Parent Navigating – helping parents navigate the system of assessment, service providers and funding portals; Building Independence Programs – working with qualified Behavioural Consultants, Speech & Languages Pathologists, Occupational Therapists on the clients Behavioural Intervention Plans; Tutoring and Special Needs Advocating and homeschooling supports.

We now employ 10 employees: Behavioural Interventionists, Educational Assistants, Tutors, Education Coordinator and 3 Program coordinators. This number will increase when we open our Child Care & Learning Centre in January 2021. The Child Care & Learning Centre is designed for 50% Special Needs children, 25% Neurotypical children and 25% ECE and Staff of the childcare and office of New Horizons Society and students enrolled in either the Early Childhood Educator or Behavioural Interventionist programs- online or in person.

Clients are referred to us from: Ministry of Children and Family Development; Autism BC; Family Support Institute of BC, Learning Disabilities Association of BC; Axis Family Resources; Maranatha Christian School; Sacred Heart Catholic School, School District 27, Interior Health and Interior Health Children's Assessment Network.
