#### D. DELEGATION(S):

## 1. Trails Update - Ian van Leusden [Late item - power point presentation]

Trails' Coordinator Ian van Leusden provided the Committee an overview of North Cariboo Trail development and the benefits of a robust trail system to market our community.

- Completed projects at Dragon Mountain Provincial Park, Wonderland Trail System, South Hills Community Trails and Pump Track and West Fraser Timber Park trail maintenance.
- Current initiatives including Kosta Cove Community Park, Quesnel Airport Fuel Treatment Trails Initiative and Claymine Low Mobility Trail.
- Future trail initiatives will see an expansion at the West Fraser Timber Park and Wonderland Phase 2.

John Courtney, Owner Rocky Peak Adventure Gear and President Gold Rush Cycling Club spoke of the extensive work on trails in our area over many years, the amazing recent progress, dramatic increase in usage and the benefits to local business.

David Lee, Owner Cycle Logic shared some small town examples of how an exciting trail system put communities on the map and, he believes the calibre of trails in Quesnel make for a bright future for cycling tourism.

## Through Committee Questions:

- Trail maintenance the Gold Rush Cycling Club are trail stewards. Additionally, we are looking into other potential partnerships to aid with early spring clean up.
- Potential capacity building and tourism opportunities cycle camps, guiding, bike rentals, link the Cariboo Chilcotin trails for a diverse experience [100 Mile, Williams Lake, Quesnel, Wells]
- Cyclists often look for campsites for accommodation, especially if the campsite has direct access to the trail network.

#### 2. Quesnel Curling Club - Manager Dave Plant

Quesnel Curling Club Manager Dave Plant confirmed that the Club is requesting that curling be incorporated under North Cariboo Recreation and Parks. As a non-profit organization, funds are limited and there are currently three pending capital projects; new refrigeration plant, new roof and new floor.

Since the date of the letter, a new refrigeration plant has emerged as an urgent priority. The compressor has failed and the Club is not in a financial position to replace the equipment. If they ordered now, installation may not occur until the new year.
