Short Summary:

Cariboo Pulp & Paper Company - Red Bluff Sewer Treatment Agreement

Voting:

Memorandum:

The Cariboo Regional District established an original agreement with the Cariboo Pulp & Paper in 1984 and subsequent agreements every five years, for the treatment of sewage from the Red Bluff area. The latest agreement has expired, and a renewed agreement is required. Under the agreement, Cariboo Pulp & Paper receives sewage from the Red Bluff pre-treatment plant and treats the sewage in the company's lagoons. The sewage flows that enter the treatment system from the Red Bluff area are measured and under the Agreement the Cariboo Regional District will pay:

Jan 1, 2020 through Dec. 31, 2020 \$0.039 per 100 gallons Jan 1, 2021 through Dec. 31, 2021 \$0.040 per 100 gallons Jan 1, 2022 through Dec. 31, 2022 \$0.040 per 100 gallons Jan 1, 2023 through Dec. 31, 2023 \$0.041 per 100 gallons Jan 1, 2024 through Dec. 31, 2024 \$0.042 per 100 gallons
