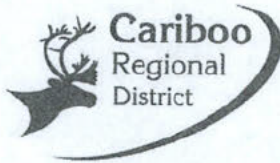

January AGM 2020 Minutes

In Attendance for January 22 2020: Alycia Rogal, Carol Ashby, Diana Shklanka, Darlene Borrow , Daesha Towle, Patricia Barron, Sindee Broen, Peter Opie, Cathie Hamm, Donna-Marie Cyr, Dean and Suzanne Spady

Meeting Called to Order: 7:02pm

Minutes: Motion to accept minutes of previous meeting (November 13 2019) as circulated by email. Seconded. Carried.

Financial Report:

Total income in the remainder of 2019 was \$3365.00 and total expenses were \$1134.85. This income and expense reports goes back to November 13th 2019. Balance in chequing account at December 31, 2019 was \$3758.30.

The January 2020 financial report has \$220.00 in income and total expenses of \$1013.02. Of these expenses, \$269.85 was payable to Darlene Borrow as she used her credit card to pay the CKC dues and to have the door lock replaced. Balance as of January 22, 2020 in the chequing account is \$2965.28. Balance of term deposits is \$5292.64.

Motion to accept financial reports. Seconded. Carried.

Items Discussed:

Old Business:

1. Obedience Classes:

Group obedience classes were scheduled to start last week but Alycia postponed them as she was sick. There is one basic manners class scheduled to start January 23rd, and a basic manners and an intro to scent detection class to start January 25th.

2. Puppy Classes:

Darlene has been doing puppy classes in the last few weeks and had 4 puppies this week. She feels it will be more productive and fair to club members that volunteer to possibly have volunteers teach puppy class for 4-6 weeks at a time and this can be scheduled 3-4 months out.

Motion: Secretary to send out an email to current club members to seek help with puppy class with a 4 week commitment. Seconded. Carried.

3. Handling Classes:

Darlene has held a couple handling classes on Tuesdays so far this year and had one for handling yesterday.

4. Fundraising:

Tabled to January 2020 meeting as the direction of fundraising will depend on status of 2020 trials.

5. June 2020 Obedience/rally trials:

The Canadian Kennel Club is very behind on approving events and in the last few days sent out a newsletter to members stating they were also very behind on approving judging panels for events. Alycia has emailed Ainsley (our contact at CKC shows and trials division) to see what the sanction match requirements are for holding future trials if we forgo 2020. She is awaiting her reply. The Stampede Association is also waiting on us to let them know whether or not our event is going ahead.

Motion: The Cariboo Kennel Club withdraws the Canadian Kennel Club application to hold obedience and rally obedience trials on May 30-31 2020. Seconded. Carried.

Motion: Apply for May 29-30 2021 dates for licensed obedience and rally obedience trials given we don't need to hold more sanction matches to be eligible. Seconded. Carried.

Alycia will withdraw the application and wait to hear if we require more sanction matches in 2020 to be eligible to host 2021 trials. She will also contact the Stampede Association to let them know our plans.

6. Building rental:

Discuss about the renting the building to generate additional income for the club. Some questions that were presented were:

- Is the landlord okay with subletting the building?
- Would the person renting need their own insurance?
- Are there concerns with leaving our club equipment out?

Motion: Darlene to investigate the possibility of subletting the building. Seconded. Failed.

Nominations of New Executive:

The New Executive was elected and is as follows:

President: Daesha Towle by acclamation

Vice President: Carol Ashby nominated by Donna-Marie Cyr - elected

Treasurer: Darlene Borrow by acclamation

Secretary: Alycia Rogal by acclamation

Alycia will contact the Canadian Kennel Club to update their club listing and contact info.

New Business:

7. Sanction matches:

Whether or not we need to plan for sanction matches depending on what the Canadian Kennel Club says we need for matches in order to be eligible to hold trials in 2021.

8. Society Renewal:

Alycia will look into filing our BC society annual report as a reminder was sent via email.

9. Stampede Grounds training area:

Just before Christmas there was a concern brought forward to the Cariboo Kennel Club from Mary Ellis of the Trail Riders Association regarding excessive barking during a training session that was disruptive to some equestrian users on that same day.

This concern has been remedied between the members involved in the training session at the stampede grounds ball diamond and the Trail Riders Association.

GENERAL INFORMATION

Club Memberships (Membership runs from Jan to Dec 31.)

Active: \$50/person; \$60 family of 2 (additional \$10/person)

Club members have the advantage of using the club's facilities – the clubhouse and the grounds – and all equipment owned by the club at no extra fee. There will be benefits for Club members in seminars, classes. Active members have the option of getting a key to the building.

Associates: \$25/person

Associate members will receive minutes and any notification of seminars, clinics, and other events of the club. They are more than welcome to join in, come to meetings, and upgrade their membership if desired. Associates will not be eligible for a key to the clubhouse, use of the equipment, or any reduction of fees for any seminar, class, or clinic.

Membership forms are in folder by door behind club brochures.

Kennel Club Keys

- Club members are also able to have their own keys to the clubhouse and gate at the grounds. Email Donna-Marie (dmcyr@teseko.com) if you want your own key(s). Obtaining the keys also means that the club members must agree to abide by the basic guidelines for key possession.

The guidelines are:

Keys are not to be duplicated (or lost!).

Keys must be returned when membership is terminated or lapsed.

Club facilities are only available to current members.

Dogs under the age of 1 year are not allowed to use the agility equipment

Members may bring a guest only to organized events (e.g. conformation handling or Rally-O handling). The guest must pay a \$5 drop-in fee each time.

Lights and heat must all be turned off/down and the club house securely locked before leaving.

At the grounds, the equipment must be put away and gate locked.
