# **Short Summary:**

Visitor Centre Contribution Agreement Renewal – City of Quesnel

# **Voting:**

#### Memorandum:

The Cariboo Regional District entered into a three-year contribution agreement in 2018 to support the operation of the Quesnel and District Visitor Information Centre, including associated tourism marketing activities.

The agreement had an initial contribution of \$10,000 per year, which is allocated to the North Cariboo Economic Development function.

A renewal is proposed for another three-year term at an increased value of \$15,000 per year. The increase is reflective of the benefits rural businesses and residents derive from centralized tourism information and regional promotion activities.
