

Scope of Project

 Permanent Acquirement of site (100 Mile Junior Secondary Tennis Courts, 485 Cedar Avenue), or alternative. The land could perhaps be donated or purchased from School District 27, or entered into a land use agreement.

Our Society has obtained several quotes and options for the project:

- Playing Surface (arena/rink) with boards and a roof
 - -removal of asphalt, site prep to a standard suitable for the cement slab
 - -Minimum excavation, fill, levelling, and soil materials required
 - -200' x 100' concrete playing surface

NHL style full fiberglass boards system, with chain link end catch fences, 2 man doors and 1 equipment door

-Engineered Steel Roof Structure: this extends the ice season, while also lowering the maintenance commitment, and making the facility more flexible in it's uses

OPTIONS: change rooms, washrooms, concession stand

Engineered Steel Roof Structure

- Having a roof could extend the ice season by as much as a month
- Reduces maintenance costs for the ice
- In the summer you can play in the rain and get out of the sun
- Roof for special events

Maintenance and Operation

We believe that this facility could be maintained and operated by the District of 100 Mile Staff (or alternatively, through a contractor) at minimal commitment and expense

- -Annual coordination with the 100 Mile Fire Department to flood the site
- -Storage and operation of the Zamboni:

must be kept in a heated facility public works yard

license the Zamboni and have staff drive it to and from the rink staff would operate the Zamboni daily we would be willing to provide training

Snow Removal

Using district equipment, or hire a contractor for the season for snow removal

District staff would maintain the surrounding area and parking lot

Summer/Off Season maintenance would be minimal

Budgetary Estimate

In initial discussions with various contractors, we have some fairly accurate quotes for the cement pad, and the roof system.

Approximately 400 yards of cement, at \$150 per yard. This is the very best cement, that will stand up to all season conditions.

Demolition, Site prep and compaction of surface area (placing of aggregate, leveling, soil testing, etc.)

Placing and finishing of cement surface

Based on our experience in maintaining the ice surface, perimeter, and parking lot, we estimate that the ice hockey season would require approximately 2 hours per day when the ice is on.

During the rest of the season, maintenance would be minimal.
