## COVID-19 prevention measures are still needed after vaccination

As the COVID-19 Immunization program continues across the North, it is important to remember that it takes time to build immunity, and public health guidelines must still be followed even after you've received a vaccine.

It takes roughly two weeks after getting the first dose of vaccine to build immunity to the virus and if you are exposed to someone with COVID-19 before or during that time, you may not yet be fully protected and can still get COVID-19.

To help prevent the spread of COVID-19 after you get a vaccine, it is still important to continue to follow public health guidelines. This includes:

- Washing your hands regularly
- Maintaining a safe physical distance
- Wearing a mask in public settings
- Staying home when sick.

It is important to note that all vaccines approved in Canada and available in B.C. are safe, effective, and will help protect against COVID-19. While COVID-19 infections post-vaccination are still possible, all vaccines have been shown to offer a high level of protection against serious illness and death.

### Outbreak declared - Acropolis Manor, Prince Rupert

NH Medical Health Officers have declared an outbreak for the West Pod at Acropolis Manor. At the time of the outbreak declaration, two residents have tested positive for COVID-19. Communication with Acropolis Manor staff, residents, and families is ongoing.

### Outbreak declared - Prince Rupert Regional Hospital, Patient Care Unit

Northern Health Medical Health Officers have declared a COVID-19 outbreak on the Patient Care Unit at Prince Rupert Regional Hospital, following lab-confirmed cases among patients on the unit. To date, three patients and one staff case have been confirmed in association with the outbreaks.


Monitoring and testing is underway to identify any additional cases.
