# Memorandum:

The Local Government Development Approvals Program is a grant funding opportunity administered by UBCM and funded by the Ministry of Municipal Affairs. The intent of the program is to support the implementation of established best practices and to test innovative approaches to improve development approvals processes while meeting local government planning and policy objectives.

Staff propose an application to the Local Government Development Approvals Program to fund improvements to our existing Building Permit and Development Application program (CityView). Upgrades to CityView and the addition of the CityView online portal would allow residents the option of applying for building permits or submitting development applications online, supporting our goal of meeting public health guidance in relation to COVID-19, and continuing to provide services to residents through this and any future emergency situations.

One of the requirements of the application is a resolution indicating support for the current proposed activities and willingness to provide overall grant management. Also of note, the deadline for the grant application is May 7, 2021, making this a time sensitive request.
