Cariboo Regional District 2021 First Quarter Financial Reports

Memorandum:

The Financial Reports for the first quarter of 2021 are presented for the Board's review. The reports cover the January 1 – March 31, 2021 operating period and show that services are where they should be at this point in the year with expenses coming in near the 25% of budget mark.

Several services reports show them significantly under budget. This is not unexpected as many expenses are dependent on the time of year and the positive variances are not expected to hold up as the year progresses. That said however, COVID19 restrictions on operations have had positive impacts on some services budgets. Governance, EA Admin and General Administration are seeing significant savings in the Travel and Meeting Expense budgets because of the switch to virtual meetings. Likewise, training budgets have seen similar results as staff training has also been virtual, removing expenses for travel, meals and lodging that normally come with this.

While the results of the first quarter look quite positive, readers are cautioned that the results may vary significantly as the year progresses. Many services have expenses that are back end loaded or do not occur on a regular schedule. While they have been budgeted for, they do not lend themselves to straight line forecasting based on the portion of calendar represented by the reporting period. One must also be aware that events can transpire that put pressure on budgets such as equipment failures and mechanical breakdowns.

As mentioned, the CRD is benefiting from reduced operating costs due to COVID-19 restrictions. As vaccinations continue and restrictions ease, it is anticipated that as things open up our operations will return to normal and expenses will return to previous levels.
