Horsefly Visitor Information Centre Roof Repair Emergency Contribution

## Memorandum:

For the Central Cariboo Directors' consideration, we have received a request for a one-time emergency contribution of \$5,000 to the Horsefly Board of Trade to contribute towards the materials for repairing a leaking roof at the Horsefly Visitor Information Centre. The labour for installation is planned to come mostly from volunteer time. The total estimated cost of the project is \$15,060, with about 50% of the expenses being for the necessary materials. Currently, the CRD has contribution agreements to support operations at the Horsefly, Likely, Williams Lake, 150 Mile, and Alexis Creek visitor centres through the Central Cariboo Economic Development function.

This funding request is above and beyond normal operations, and the funds for the emergency repair are available in the Central Cariboo Economic Development budget due to an infusion in 2021 through COVID Safe Restart Funding. The purpose of this increased funding is to provide relief for unforeseen costs to local government and aligns with Board's strategic objective to *Foster an environment to ensure the economic sustainability of CRD communities and the region*.
